*Accident Compensation (WorkCover Insurance)
Act 1993*

PROCLAMATION OF COMMENCEMENT
OF SPECIFIED SECTIONS

I, Richard E. McGarvie, Governor of Victoria, acting with the advice of the Executive Council and under section 2 (3) of the *Accident Compensation (WorkCover Insurance) Act 1993*, No. 50/1993, fix—

- (a) 16 June 1993 as the day on which Part 3, and sections 7, 8, 9, 10, 11, 15, 16, 17, 72, 78 (1) (b), 79, 80 (1) (a) and (e), 85, 86, 89, 90, 98, 103, 104, 105, 106, 107, 108, 109 (1) and (2), 112 (2) and 113 of that Act comes into operation;
- (b) 30 June 1993 as the day on which sections 12, 13, 14, 18, 20, 21, 22, 23, 24, 25, 26, 55, 57, 58, 59, 60, 61, 62, 63, 64, 65, 66, 67, 68, 69, 70, 71, 73, 75, 78 (1) (c), (d), (e), (f), (g) and (h) and (2), 83 and 101 of that Act comes into operation;
- (c) 1 July 1993 as the day on which Part 4 and sections 56, 74, 76, 78 (1) (a), 80 (1) (b), (c) and (d), 80 (2), 81, 84 (2), 91, 99 and 109 (3) of that Act comes into operation; and
- (d) 1 August 1993 as the day on which sections 96 and 97 of that Act comes into operation.
