## FISHERIES (SCALLOP FISHING—OCEAN FISHERY) (AMENDMENT) NOTICE No. 22/1993

#### Title

1. This notice may be cited as the Fisheries (Scallop Fishing—Ocean Fishery) (Amendment) Notice No. 22/1993.

#### Commencement

2. This notice comes into operation on 19 September 1993.

#### Objective

3. The objective of this Notice is to amend the weekly catch rate limit (bag limit) for the taking of scallops from Victorian waters, other than Port Phillip Bay.

#### Authorising provision

4. This Notice is made under section 80 of the Fisheries Act 1968.

#### Amendment of weekly catch rate limit

- 5. In the \*Fisheries (Scallop Fishing—Ocean Fishery) Notice No. 19/1993, for clause 7 substitute—
- "7 (1) A master fisherman operating a registered fishing boat for which an appropriately endorsed scallop licence has been issued is permitted to take from that boat from Victorian waters other than Port Phillip Bay or have on board that boat on Victorian waters other than Port Phillip Bay or have on board that boat on Victorian waters other than Port Phillip Bay or have on board that boat on Victorian waters other than Port Phillip

Bay more than the weekly catch rate limit (bag limit) of scallops.

- (2) For the purpose of sub-clause (1) the weekly catch rate limit (bag limit) for the taking of scallops is—
  - (a) 30 crates of scallops per week; or
  - (b) 80 sacks of scallops per week."

#### Title

1. This notice may be cited as the Fisheries (Scallop Fishing—Port Phillip Bay Fishery) (Amendment No. 2) Notice No. 23/1993.

# Commencement

2. This notice comes into operation on 20 September 1993.

## Objective

3. The objective of this Notice is to amend the fishing times and the weekly catch rate limit (bag limit) for the taking of scallops from Port Phillip Bay.

## Authorising provision

4. This Notice is made under section 80 of the Fisheries Act 1968.

# Amendment of fishing times

5. In the \*Fisheries (Scallop Fishing—Port Phillip Bay Fishery) Notice No. 21/1993, for clause 6 (1) substitute—

"6 Subject to section 15 (1) (h) of the Act the holder of a scallop licence endorsed—"valid for scallop fishing in all Victorian waters" or "valid for scallop fishing in the waters of Port Phillip Bay" must only dredge for or take scallops for sale from the waters of Port Phillip Bay—

- (a) on any Monday, on any Tuesday, on any Wednesday and on any Thursday; and
- (b) between the hours of 5.00 a.m. and 5.00 p.m. on the days on which dredging for or taking of scallops is permitted under paragraph (a)."

# Amendment to daily catch rate limits

- 6. In the \*Fisheries (Scallop Fishing—Port Phillip Bay Fishery) Notice No. 20/1993, for clause 7 substitute—
- "7 A master fisherman operating a registered fishing boat for which an appropriately endorsed scallop licence has been issued must not take from Port Phillip Bay or have on board that boat on Port Phillip Bay more than six (6) crates of scallops on any one day."
