MALVERN PLANNING SCHEME
Notice of Approval of Amendment
Amendment L20

The Minister for Planning has approved Amendment L20 to the Malvern Planning Scheme.

The amendment comes into operation on the date this notice is published in the *Government Gazette*.

The amendment rezones land, being 128 Tooronga Road, Glen Iris, from Residential C Zone to Restricted Business Zone to correct an error on the planning scheme map.
