Planning and Environment Act 1987 ALTONA PLANNING SCHEME Notice of Approval of Amendment Amendment L36

The Minister for Planning has approved Amendment L36 to the Local Section of the Altona Planning Scheme.

The Amendment comes into operation on the date this notice is published in the *Government Gazette*.

The amendment extends the expiry date of controls in the Altona Special Industrial Zone, the Altona Reserved Industrial Zone and the Altona Garden Industrial Zone until 31 December 1993. The controls affect land at and around the Altona petrochemical complex.
