City of Melbourne Act 1993 PROVISION OF SERVICES AND FUNCTIONS IN THE NORTH CARLTON AREA

I, Roger M. Hallam, Minister for Local Government, acting under section 25 of the *City of Melbourne Act 1993* (the Act), specify that the following services area to be provided and the following functions are to be performed by the Melbourne City Council as from the date the Act receives Royal Assent until 30 September 1994 in relation to the area severed by the operation of the Act from the municipal district of the City of the Melbourne and annexed to the municipal district of the City of Fitzroy:

- Collection of residential refuse;
- Collection of residential recycling;
- Collection of commercial refuse;
- Collection of hard rubbish;
- Street cleaning;
- Clearance of litter bins in public places;
- Removal of graffiti in public places;
- Maintenance of street furniture;
- Control of weeds in lanes, footways and channels;
- Construction and maintenance of drains;
- Reconstruction and maintenance of roads and footpaths, including reinstatements;
- Completion of works, including associated mechanical services, included in the 1993-94 capital works program in relation to drains, roads, footpaths, parks and gardens, municipal buildings and traffic management;
- Street lighting;
- Maintenance of median strips, tree islands, roundabouts, lawns and nature strips;
- Maintenance of street trees;
- Provision of street flower containers;
- General maintenance of parks, gardens, reserves and open spaces, including maintenance of plumbing and irrigation systems, collection of rubbish and maintenance of general infrastructure;

- Cleaning public conveniences;
- Public lighting in parks, gardens, reserves and open spaces;
- Traffic management;
- Parking management;
- Maintenance of voters roll;
- Maintenance of rating and property records;
- Carrying out of general and supplementary valuations;
- Maintenance of municipal buildings;
- Completion of minor works at Bocce Courts, Hardy Gallagher Reserve;
- Public health services, excluding statutory responsibilities under the *Food Act 1984*, *Dog Act 1970*, *Health Act 1958* and the *Summary Offences Act 1966*;
- Maternal and child health services provided at Pidgon Street Maternal and Child Health Centre and Newry Street Maternal and Child Health Centre;
- Pre-school and child care services provided at North Carlton Children's Centre/Preschool and Princess Hill Children's Centre/Preschool;
- Jolly Bus Service operated from North Carlton's Children's Centre;
- Recreation and vacation care services provided at Princes Hill School Park Centre;
- Library services provided at Carlton Library;
- Neighbourhood liaison officer scheme;
- Carlton Contact;
- Access to Melbourne Integrated Dental Health Service;
- Community facilities at 150 Princes Street;
- Canning Street residential unit until 31 December 1993;
- Solly Avenue neighbourhood house;
- Community Arts Projects;
- Access to the following services and facilities located in the municipal district of the City of Melbourne: family support services, baby bassinet scheme and children's resource services provided at the

Carlton Family Resource Centre, the youth program provided by the Carlton Estate Residents Association, the Carlton Gardens Holiday Program, the Carlton Gardens After School Program, the Carlton Baths Holiday Program, Home and Community Care Services, the Waste Management Centre at Dynon Road, the Carlton Senior Citizens Centre, the Carlton Community Centre and Baths, the Central Carlton Preschool Centre and the Adult Day Centre.
