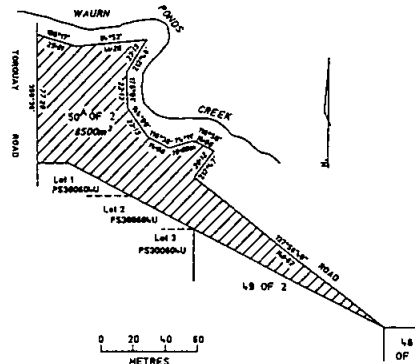

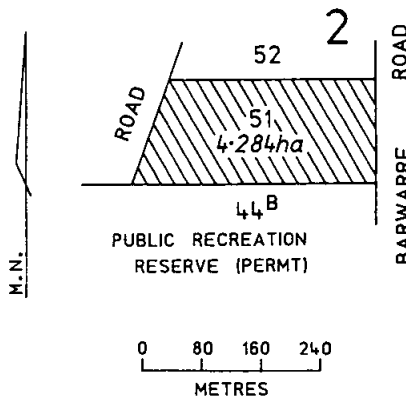

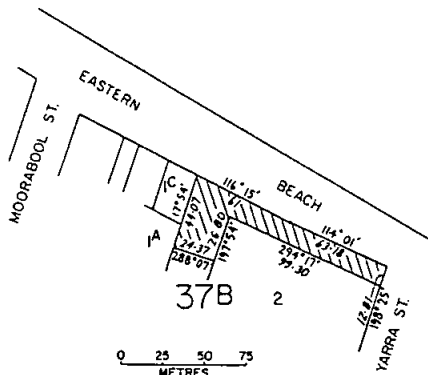

WHITTLESEA PLANNING SCHEME

Notice of Amendment to a Planning Scheme Amendment L93

The City of Whittlesea has prepared Amendment L93 to the Whittlesea Planning Scheme.

The amendment affects land at 347–371 Dalton Road, Epping.

The amendment proposes to change the Planning Scheme by rezoning a small portion of the existing title located at the rear on the western boundary of the land from Reserved Living to Neighbourhood Business to correct a minor anomaly. The remainder of the land is zoned Neighbourhood Business.

The land is proposed to be developed with a neighbourhood shopping centre.

The amendment can be inspected at City of Whittlesea, Municipal Offices, McDonalds Road, South Morang and The Department of Planning and Development, Ground Floor, 477 Collins Street, Melbourne.
