Proposed Local Laws Environmental Health (Open Air Burning and Incinerators) Local Law No. 9

Notice is hereby given that at a meeting of the Council of the Shire of Lillydale, held on 9 March 1993, the Council resolved to propose to make a Local Law titled "Environmental Health (Open Air Burning and Incinerators) Local Law No. 9" pursuant to the provisions of the Local Government Act 1989.

The purpose of the proposed Local Law is to:

- (a) minimise the outbreak of fire;
- prevent and abate nuisances caused by (b) fire:
- regulate the lighting of fire in the open air:
- regulate the lighting of fires in incinerators;

- (e) provide for environmental control, protection and conservation;
- (f) minimise the incidence of airborne pollution; and
- prevent the disposal of waste by (g) burning.

The general purport of the Local Law is that it regulates the burning of any material or substance, where the affect of burning causes a nuisance is liable to be injurious or prejudicial to health or is offensive to any person. The Law further controls the days, times and under what conditions fires may be lit.

The Local Law empowers authorised officers, provides for infringement notices and has offence and penalty clauses.

Owners, occupiers or persons who fail to comply with the provisions of the Local Law shall be guilty of an offence and may incur penalties of up to \$2000.

Some of the major provisions deal with:

Area of operation;

Burning generally;

Nuisance and prohibited materials;

Fires on roads:

Fires in the open air:

Fires in incinerators;

Restrictions within residential areas;

Restrictions within high fire risk areas;

Restrictions as to times and days;

Applications for permits;

Form of permit;

Revocation of permit;

Currency of permit;

General duties of residents;

Directive powers.

The Local Law specifies that persons must not in the open air or in an incinerator except at certain times:

- 1. Light or allow to remain alight a fire except in accordance with the conditions of the proposed Local Law or with a permit granted under the Local Law or unless the fire is authorised or directed to be lit under the provisions of any legislation.
- 2. Burn any matter, material or substance in such a manner or to such an extent as to-
  - (a) cause any nuisance;
  - (b) be liable to be injurious or prejudice to human health; or
  - (c) be offensive to any person.

- 3. Unless expressly permitted to do so under any other legislative enactment, burn any—
  - (a) rubber or plastic or similar petroleum base substance;
  - (b) petroleum oil or material containing petroleum oil or similar substance;
  - (c) paint or receptacle which contains or has contained paint;
  - (d) chemicals manufactured or otherwise;
  - (e) food waste of any type;

  - H. R. Craig;
  - I. Ellis;
  - S. P. Kennet;
  - S. Craig.
  - 7. The Former Authorities are abolished.
- 8. The Interim Membership of the New Authority is all the existing members of the Kiewa River Improvement Trust, the Mitta

Victoria Government Gazette Mitta River Improvement Trust and the Shire of Upper Murray River Improvement Trust.

- 9. The New Authority shall comprise 11 members as follows:
  - 1 member appointed by the Council of the Shire of Yackandandah;
  - 1 member appointed by the Council of the Shire of Bright;
  - 1 member appointed by the Council of the Shire of Tallangatta;
  - 1 member appointed by the Council of the Shire of Upper Murray;
  - 1 member appointed by the Council of the Rural City of Wodonga;
  - 2 Ministerial Nominees from the Mitta Mitta Waterway District;
  - 2 Ministerial Nominees from the Shire of Upper Murray Waterway District;
  - 2 Ministerial Nominees from the total catchments.
- 10. (a) This is an Order referred to in section 98 (2) (a) of the Act.
- (b) Under section 100 (2) (a) of the Act the affected Authorities, the Kiewa River Improvement Trust, the Mitta Mitta River Improvement Trust and the Shire of Upper Murray River Improvement Trust, have applied to me for this Order to be made.





### **RACING ACT 1958**

The Governor of Victoria acting with the advice of the Executive Council and pursuant to the powers conferred by section 116HA of the Racing Act 1958 does by this Order:

- (a) acknowledge an Agreement made on 26 May 1993 between the Totalizator Agency Board of Victoria and the Chung Corporation Limited of Port-Vila, Vanuatu, for the provision of telephone betting facilities;
- (b) acknowledge the grant of a Totalizator Operators Licence to the Chung Corporation Limited by the Government of the Republic of Vanuatu under the provisions of section 6 of the Betting (Control) Act 1993:
- (c) determine that the provisions of the Racing Act 1958 be subject to such alterations and modifications as are detailed in the Schedule, which are necessary and expedient to give effect to the Agreement.

### **SCHEDULE**

# 1. Section 1160 of the Act is modified to the extent that:

- (1) Commission deducted under section 102 (1) of the Act which the club conducting the totalizator is informed by the Board is derived from bets made through the Board under the Agreement is to be paid by the club to the Board within fourteen (14) days of the race meeting and the commission so received is to be distributed as follows:
  - (a) an amount equal to 0.5% of the total of bets made through the Board under the Agreement is to be paid to the Consolidated Fund;

- (b) the balance of the commission is to be distributed in accordance with the terms of the Agreement.
- (2) Unclaimed dividends and refunds accruing in respect of investments made through the Board under the Agreement are to be paid by the Board to the Government of Vanuatu.

# 2. Section 116AK is modified to the extent that:

Unclaimed dividends and refunds accruing in respect of investments made through the Board under the Agreement are to be paid by the Board to the Government of Vanuatu.

# 3. Section 116AN is modified to the extent that:

Commission deducted in respect of bets received by the Board under the terms of the Agreement is to be distributed as follows:

- (a) an amount equal to 0.5% of the total of bets made through the Board under the Agreement is to be paid to the Consolidated Fund;
- (b) the balance of the commission is to be distributed in accordance with the terms of the Agreement.

# 4. Section 116BK is modified to the extent that:

Unclaimed dividends and refunds accruing in respect of investments made through the Board under the Agreement are to be paid by the Board to the Government of Vanuatu.

### 5. Section 116BM is modified to the extent

Commission deducted in respect of bets received by the Board under the terms of the Agreement is to be distributed as follows:

- (a) an amount equal to 0.5% of the total of bets made through the Board under the Agreement is to be paid to the Consolidated Fund;
- (b) the balance of the commission is to be distributed in accordance with the terms of the Agreement.

### 6. Section 116cg (1) is modified to the extent

Commission deducted in respect of bets received by the Board under the terms of the Agreement is to be distributed as follows:

 (a) an amount equal to 0.5% of the total of bets made through the Board under the terms of the Agreement is to be paid to the Consolidated Fund;

(b) the balance of the commission is to be distributed in accordance with the terms of the Agreement.

### 7. Section 105A is modified to the extent that:

Where the amount of any dividend declared payable in respect of bets received by the Board under the Agreement is less than fifty cents the amount required to make up the difference between the calculated dividend and the minimum dividend of fifty cents shall, in respect of such bets, be deducted from the commission otherwise distributable under the terms of the Agreement.

# 8. Section 116CE (2) is modified to the extent that:

Where the amount of any dividend declared payable in respect of bets received by the Board under the Agreement is less than fifty cents the amount required to make up the difference between the calculated dividend and the minimum dividend of fifty cents shall, in respect of such bets, be deducted from the commission otherwise distributable under the terms of the Agreement.
