

At the Ordinary Meeting of the Council of the City of Bendigo held on 7 June 1993, the following resolution was passed:

- 1. That pursuant to section 528 of the Local Government (Miscellaneous) Act 1958, the two private unnamed roads situated in the block bounded by Lyttleton Terrace, Mundy Street, Market Street and St Andrews Avenue, being part of Crown Allotment 3, 4 and 19, Section 9c at Bendigo, Parish of Sandhurst, shall be discontinued upon publication of this resolution in the Government Gazette.
- 2. That the land in the said road shall be consolidated with the surrounding titles owned by the City of Bendigo.

Environmental Health (Food Premises)

Notice is hereby given that the Council of the City of Coburg proposes to make a Local Law for the following purpose—

- (a) ensure that any proprietor of food premises complies with Council's Food Premises Code;
- (b) impose obligations on a proprietor of food premises applying for

- registration or renewal of registration, or a proprietor of food premises becoming the transferee of registration, of those premises;
- (c) ensure that, while food premises are open to members of the public or otherwise being used in relation to the manufacture, preparation, packaging, sale or serving of food, the proprietor and all food handlers present on the premises have satisfactorily completed a course approved by Council's Manager, Health Services; and
- (d) enable Council to exempt a proprietor from certain of the obligations imposed by the Local Law.

The general purport of Local Law No. 21 is as follows:

- (a) To ensure a proprietor of food premises complies with Council's Food Premises Code.
- (b) To impose obligations on a proprietor of food premises applying for registration or renewal of registration, or a proprietor of food premises becoming the transferee of registration, of those premises.
- (c) To ensure that, while food premises are open to members of the public or otherwise being used in relation to the manufacture, preparation, packaging, sale or serving of food, the proprietor and all food handlers present on the premises have satisfactorily completed a course approved by Council's Manager, Health Services.
- (d) To enable Council to exempt a proprietor from certain obligations imposed by the Local Law.
- (e) To provide for offences if a person contravenes or fails to comply with the Local Law.

A copy of the Local Law can be obtained from the Council Office, Bell Street, Coburg during office hours.

Any person affected by the proposed local law may make a submission relating to the proposed local law under section 223 of *Local Government Act* 1989 and all submissions must be lodged within fourteen (14) days of the publication of this notice.

DIVISION 1—PRELIMINARY PROVISIONS

Details the title, purpose, authorising provision, commencement and revocation dates of the Local Law, area of operation, and definition of words and phrases used in the Local Law.

DIVISION 2—PARKING

Clause 7-

- (a) The owner of; and
- (b) A person who leaves a motor vehicle standing in a parking area must ensure that such motor vehicle is not left standing in that parking area:
 - (i) on a day other than a day;
 - (ii) at a time other than a time; or
 - (iii) for a period exceeding a period allowed by Council.

DIVISION 3—RESIDENT PARKING SCHEMES

Resident Parking Areas

Clause 8-Council may set aside an area as a "resident parking area".

Residents may be Applicants

Clause 9-A person who resides within an area set aside as a "resident parking area" may apply for a parking permit in respect of each motor vehicle of which he or she is the sole or joint owner or user, together with a parking permit referable to any person visiting him or

Applicants for Permits

Clause 10-The Applicant must lodged with the Municipal Clerk an Application in a form approved by Council.

Clause 11—The Council may, in its discretion, grant an Application, grant an Application with conditions, or refuse to grant an Application.

Issue and Form of Permit

Clause 12-Any permit granted by Council shall be in a form approved by Council, and effective only upon the payment of any permit fee fixed by Resolution of Council.

Revocation of Permit

Clause 13—If, in the opinion of Council—

(a) the permit-holder has failed to comply with the conditions of the permit;

- (b) there has been a material misstatement or concealment of fact in relation to the grant of the permit;
- (c) there has been a material change of circumstances since the grant of the permit; or
- (d) the permit-holder no longer resides within the area set aside as a "resident parking area",

it may revoke the permit.

Currency of Permit

Clause 14-

- (a) Unless it is sooner revoked, a permit will continue in force for the period specified in the permit; and
- (b) The permit-holder must not assign, transfer or encumber his or her permits.

Obligations of Permit-holder

Clause 15—A permit-holder or other person visiting the permit-holder must:

- (a) affix the relevant permit against or adjacent to the interior of the windscreen of the relevant motor vehicle; and
- (b) ensure that all-
 - (i) printed material; and
 - (ii) figures and symbols appearing on the permit are capable of being read by any person standing

immediately beside the motor vehicle.

Rights of Permit-holder

Clause 16—A permit-holder or person visiting the permit-holder under this Division who complies with—

- (a) Clause 15; and
- (b) the conditions of the relevant permit; shall be exempt from Clause 9 if any motor vehicle owned or used (whether solely or jointly) by him or her is left standing in a "resident parking area".

DIVISION 4—COUPON PARKING

Coupon Parking Area

Clause 17—Council may set aside an area as a "coupon parking area".

General Prohibition

Clause 18—The owner of any motor vehicle which is left standing in a "coupon parking area" must ensure that a coupon—

- (a) issued by or on behalf of Council;
- (b) validated in accordance with the instructions detailed in such coupon; is immediately and remains affixed against or adjacent to the interior of the windscreen of the motor vehicle, such that all—
 - (i) printed material; and
 - (ii) figures and symbols

appearing on the coupon are capable of being read by any person standing immediately beside the motor vehicle.

Clause 19—The owner of any motor vehicle which is left standing in a "coupon parking area" and who complies with Clause 18 must ensure that:

- (a) such motor vehicle is not left standing for a period exceeding that—
 - (i) which is allowed; or
 - (ii) for which the coupon is or remains operative;
- (b) the coupon affixed in accordance with Clause 18 is not transferred to any other motor vehicle; and
- (c) any conditions appearing on the coupon are observed.

DIVISION 5—PARKING AND DISABLED MOTORISTS

General Prohibition

Clause 20—A person must not, without a disabled person's parking permit nor otherwise than in accordance with the conditions of such a permit:

- (a) leave a motor vehicle standing; or
- (b) own a motor vehicle which has been left standing;

in a parking space set aside for the holder of a "disabled person's parking motorist permit".

Privileges of Permit-holder

Clause 21—Notwithstanding Clause 9, a person may leave a vehicle standing in a parking area for twice the period allowed by Council if—

- (a) there is exhibited on the vehicle a "disabled person's parking permit";
- (b) the manner of exhibition is in accordance with the Code of the Disabled Person's Parking Scheme; and
- (c) the vehicle is left standing in accordance with the conditions of the permit.

Infringement Notices

Clause 22—Provides for the serving of Infringement Notices as an alternative to prosecution.

Offences and Penalties

Clause 23—A person who contravenes this Local Law is guilty of an offence, and liable to a penalty—


- (a) for an initial offence, not exceeding 10 penalty units (\$1000.00); and
- (b) for a subsequent offence, not exceeding 20 penalty units (\$2000.00).

Payment in lieu of Car Parking Local Law

Notice is given that at a meeting of the Council of the City of Melbourne held on 5 July 1993, the Council resolved to propose to make a Local Law titled "Payment in lieu of Car Parking Local Law" pursuant to the provisions of the Local Government Act 1989.

The objective of this Local Law is to provide, by the payment of money to the Council, for the discharge of an obligation to provide car parking space.

Under the proposed Local Law the Council or delegate may discharge any person from any obligation he or she would otherwise have under any Act, regulation or Local Law to provide car parking spaces on any land, on condition that he or she pays to the Council the amount of money specified by the Council.

The Local Law also details how an application for discharge must be made, how the amount to be paid will be determined, methods of payment and that the funds collected by the Council can only be used for the provision of car parking.

A copy of the Local Law can be obtained, free of charge, from the Office of the Town Clerk, 3rd Floor, Town Hall, Swanston Street, Melbourne, during office hours (i.e. 8.00 a.m. to 5.00 p.m. daily from Monday to Friday).

 - (b) who is recorded by the Librarian as continuously holding a book for six months past the due date of return of that book; or
 - (c) who does not pay to the Council the full replacement value of a book that is lost or damaged beyond repair while borrowed by that member.
 - 23 (3) If a person whose membership has been suspended or cancelled pursuant to sub-clause (2) makes good the non-return, loss or damage of the relevant book, the Librarian must readmit that person as a member."; and
- (b) repositioning the definition of "library service area" after the definition of "library".





SUNSHINE PLANNING SCHEME Explanatory Statement Amendment No. L51

Part 1—This amendment has been prepared by the City of Sunshine and proposes to amend the Local Section of the Sunshine Planning Scheme

The amendment proposes to rezone the land bounded Hampstead Road and Crefden Street from Public Purpose (Office of Defence Production) Reservation to Manufacturing 3 Zone

The site is occupied by the Footscray West Mail Centre.

The aim of the amendment is to reflect the Mail Centre's new corporate structure and operation. In addition, the proposed rezoning is considered to be in accordance with State Government policy to accommodate any industrial rezonings within the new manufacturing zones.

Part 2—This amendment has been prepared by the City of Sunshine at the request of the Ministry of Finance and proposes to amend the Local Section of the Sunshine Planning Scheme.

This amendment proposes to create a Road Closure Reservation over a disused right-of-way between Barb Street and Chicago Street, Maribyrnong. No access to adjacent properties is gained from the reserve.

This amendment will enable the vesting of the land in the Minister administering the Land Act 1958. The land will then be able to be transferred to adjacent properties as detailed in section 43 of the Planning and Environment Act 1987.

Part 3—The controls for the Sunshine District Centre No. 2 Zone (Clause 106) are proposed to be modified to provide some variation to the type of commercial activities which may establish within the zone. Subject to a permit, a shop could be established which has a floor area exceeding 1000 sq. m. and which would normally not appropriately locate within the Sunshine District Centre No. 1 Zone. This could cover a retail activity which does not fall within the peripheral sales definition, but is similar in nature and is preferably located on the periphery of the core retail area. The provisions regarding the preparation of a Development Plan (Clause 106-5) are also proposed to be modified to provide for a development plan to be prepared in stages having regard to land holdings and likely staging of development. A correction is also proposed to be made to the Development

Plan provisions (Clause 106–5) where provision for a child minding centre and baby change facilities were inserted. Those provisions are included in the Sunshine District Centre No. 1 Zone and were not intended to be specifically required in the Sunshine District Centre No. 2 Zone.

In Clause 106–1.2 under the heading "Condition" opposite to "Shop" alter to read:

"The floor area within land described in Certificate of Title Vol. 5336 Folio 069 must not exceed 280 sq. m."

"Where a shop requires a floor area exceeding 1000 sq. m. and the nature of the retail activity is such that it would not be appropriate to locate it in the Sunshine District Centre No. 1 Zone."

In Clause 106–1.3 under the heading "Use", after the words "S hop other than Convenience Shop or Take-away Food Premises", add "or where the condition in Section 2 is not met."

In Clause 106-5 after the first paragraph add a new paragraph:

"The development plan may be prepared in stages having regard to land holding and likely staging of development in the zone." In Clause 106-5 delete the following:

"Provision of a child minding centre to cater for up to 35 children.

Provision of baby changing facilities and public toilets."



- (c) to regulate droving of livestock to prevent damage to vegetation, adjoining properties, road pavements, etc., and to prevent the spread of disease and noxious weeds;
- (d) to control droving to provide for the safety of users of streets and roads;
- (e) to require secure fencing of land;
- (f) to allow impounding of livestock in appropriate circumstances;
- (g) to provide for fees and penalties.

Local Law No. 7—Streets and Roads Local Law

This Local Law is made for the purpose of regulating and controlling—

- (a) the management of traffic, use of roads by persons vehicles and animals and to regulate the parking of vehicles for the safety and fair use by people in the municipal district;
- (b) to provide for the peace order and wellbeing of people in the municipal district;
- (c) to provide for the physical features of the road and adjacent properties to be managed in a way which attends to the safety and convenience of people travelling on or using the road;
- (d) to control various types of vehicles for the safety and convenience of road users;





Section 100(1) of the Accident Compensation Act 1985 stipulates that amounts in Part IV and in section 5A of the Act are varied on 1 July in each year in line with the movement in the average weekly earnings for all employees in Victoria between the two previous December quarters, using the latest figures published by the Australian Statistician as at 15 June following the previous December quarter. Weekly payments are indexed on the anniversary of the entitlement to weekly payments as detailed in Section 100(2) of the Act.

Section 100(3A) was recently introduced into the legislation to ensure that an amount is not reduced through the indexation process. This section provides that where there is a reduction in average weekly earnings over the relevant period, the amount being indexed is not reduced, but there will be an offset against future indexation increases.

The average weekly earnings for all employees during the December quarters of 1991 and 1992 reduced from \$512.00 to \$504.80. In accordance with section 100(3A), amounts are not reduced at 1 July 1993.

Legal Profession Practice Act 1958 SOLICITORS' (AUDIT AND PRACTISING CERTIFICATES) (AMENDMENT No. 1) RULES 1993

In the pursuance of the powers conferred by the Legal Profession Practice Act 1958 and all other powers thereunto enabling the Council of the Law Institute of Victoria hereby makes the following Rules:

- 1. These Rules may be cited as the Solicitors' (Audit and Practising Certificates) (Amendment No. 1) Rules 1993 and shall come into operation on the date of their publication in the *Victoria Government Gazette*.
- 2. The Solicitors' (Audit and Practising Certificates) Rules 1990 are in these Rules referred to as the Principal Rules.
- 3. Rule 41 of the Principal Rules is repealed and the following substituted for it—
- "41. (1) Subject to sub-rules (3), (4) and (5), the practising certificate fees for the year 1993 shall be:
 - (a) For a Full Practising Certificate—
 - (i) For solicitors who principally practise in Victoria and who have not reached the age of 68 years— \$515.00;
 - (ii) For solicitors who principally practise in Victoria and who have reached the age of 68 years— \$310.00;
 - (iii) For solicitors who principally practise outside Victoria— \$257.50;
 - (b) For an Employee Practising Certificate or a Corporate Practising Certificate—
 - (i) For solicitors who principally practise in Victoria and who have been admitted as practitioners of the Supreme Court of Victoria before 1 November of the year before application for the practising certificate—\$310.00;
 - (ii) For solicitors who principally practise in Victoria and who have been admitted as practitioners of the Supreme Court of Victoria in the year of or in the months of November or December of the year before application for the practising certificate—\$170.00;
 - (iii) For solicitors who principally practise outside Victoria— \$155.00;

- (c) For an Incorporated Practitioner's Practising Certificate—\$55.00.
- (2) Subject to sub-rules (3), (4) and (5), the practising certificate fees for the year 1994 and subsequent years shall be:

 - (ii) For solicitors who principally practise in Victoria and who have reached the age of 68 years— \$328.00;
 - (iii) For solicitors who principally practise outside Victoria— \$272.50:
 - (b) For an Employee Practising Certificate or a Corporate Practising Certificate—
 - (i) For solicitors who principally practise in Victoria and who have been admitted as practitioners of the Supreme Court of Victoria before 1 November of the year before application for the practising certificate—\$328.00;
 - (ii) For solicitors who principally practise in Victoria and who have been admitted as practitioners of the Supreme Court of Victoria in the year of or in the months of November or December of the year before application for the practising certificate—\$180.00;
 - (iii) For solicitors who principally practise outside Victoria— \$164,00;
 - (c) For an Incorporated Practitioner's Practising Certificate—\$58.00.
- (3) For solicitors who practise as employees of the Legal Aid Commission of Victoria the fee for a practising certificate shall be \$115.00 in 1993 and \$120.00 in 1994 and subsequent years.
- (4) For solicitors who apply for a practising certificate to commence between 1 July and 31 October of any year, the fee for a practising certificate shall be half that otherwise payable.
- (5) Solicitors who apply for a practising certificate to commence on or after 1 November of any year need not pay a fee provided that at the time of application the solicitor has applied and paid the fee for a practising certificate for the following year.

- (6) An honorary life member of the Institute need not pay a practising certificate fee.
- (7) The practising fee payable in accordance with this Rule shall be paid to the Secretary of the Institute on lodging the application to which it relates.
- (8) A solicitor who surrenders a practising certificate between 1 January and 31 March of the year of its currency shall be entitled to a refund of three quarters of the fee paid for the certificate.
- (9) A solicitor who surrenders a practising certificate between 1 April and 30 June of the year of its currency shall be entitled to a refund of one half of the fee paid for the certificate.
- (10) A solicitor who between 1 January and 31 March of any year surrenders a Full Practising Certificate and immediately applies for an Employee Practising Certificate or a Corporate Practising Certificate for the same year shall be entitled to a refund of three quarters of the difference between the fee paid by the solicitor for the Full Practising Certificate and the Employee Practising Certificate or Corporate Practising Certificate.
- (11) A solicitor who between 1 April and 30 June of any year surrenders a Full Practising Certificate and immediately applies for an Employee Practising Certificate or a Corporate Practising Certificate for the same year shall be entitled to a refund of one half of the difference between the fee paid by the solicitor for the Full Practising Certificate and the Employee Practising Certificate or Corporate Practising
- (12) A solicitor who between 1 July and 30 September of any year surrenders a Full Practising Certificate and immediately applies for an Employee Practising Certificate or a Corporate Practising Certificate for the same year shall be entitled to a refund of one quarter of the difference between the fee paid by the solicitor for the Full Practising Certificate and the Employee Practising Certificate or Corporate Practising Certificate.
- (13) A solicitor who between 1 January and 30 June of any year surrenders an Employee Practising Certificate or a Corporate Practising Certificate and immediately applies for a Full Practising Certificate for the same year shall pay the full difference between the fee paid by the solicitor for the Employee Practising Certificate or Corporate Practising Certificate and the fee payable for the Full Practising Certificate.

- (14) A solicitor who between 1 July and 31 October of any year surrenders an Employee Practising Certificate or a Corporate Practising Certificate and immediately applies for a Full Practising Certificate for the same year shall pay one half of the difference between the fee paid by the solicitor for the Employee Practising Certificate or Corporate Practising Certificate and the fee payable for the Full Practising Certificate.
- (15) A solicitor who between 1 November and 31 December of any year surrenders an Employee Practising Certificate or a Corporate Practising Certificate and immediately applies for a Full Practising Certificate for the same year shall not pay any additional fee."
