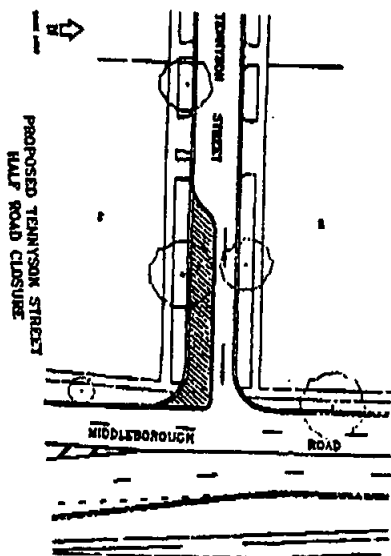

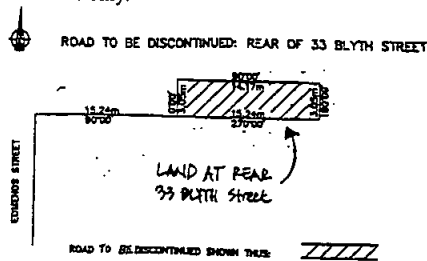

- (b) The land in the said road subject to any such right, title, power, authority or interest vesting in the municipality to be retained by it until sold by private treaty.



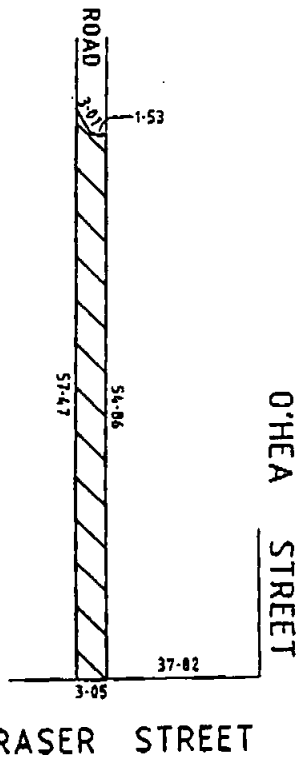

COBURG CITY COUNCIL
Road Discontinuance

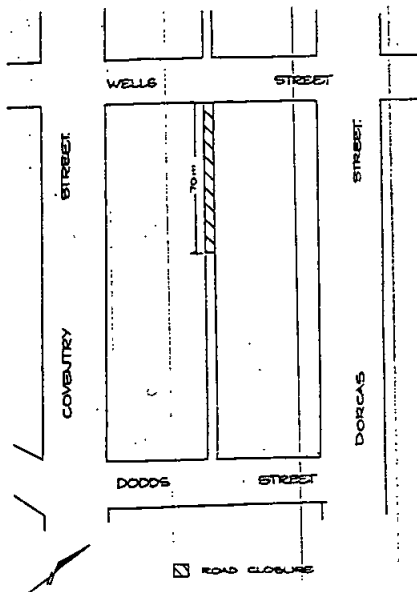

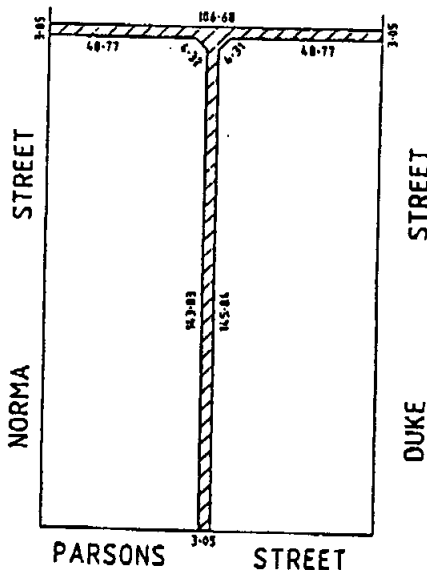

Local Law for the Peace, Order and Good Government of the Municipal District

Notice is given that the Council of the Shire of Ararat proposes to make a set of Local Laws for the Peace, Order and Good Government of the Municipal District.

The purpose of the Local Laws is to:

1. Control occupancy and occupations of a temporary nature;
2. Regulate the keeping of animals within townships and other residential areas and to control pest animals;
3. Protect Council land and control certain activities on Council land;
4. Provide for and protect elements of public safety, public amenity and security of property;
5. Protect the safety and convenience of people using roads, streets and footpaths;
6. Control the movement of livestock on roads, so as not to cause a nuisance, traffic hazard, health risk or environmental damage;
7. Regulate and control road names, advertising on roads, roadside trading and displays, and occupation of the roads for works;
8. Control the siting of buildings in accordance with regulations and to provide exemptions from building approval for certain farm buildings.

UNITED SHIRE OF BEECHWORTH
Local Law No. 6A

Notice is hereby given that the Council of the United Shire of Beechworth, at its meeting held on 1 September 1993, made Local Law No. 6A, titled "Local Law to Regulate or Prohibit Certain Uses of Roads and Public Carparks".

This Local Law is made for the purpose of:

- (a) Providing for the peace, order and good government of the United Shire of Beechworth;
- (b) Regulating or prohibiting certain uses of roads and public car parks to protect public safety, convenience and amenity within the Municipal District;
- (c) Regulating or prohibiting certain uses of roads and public car parks to

preserve the integrity of the streetscape of the Township of Beechworth;

- (d) Requiring certain permit holders under this Local Law to indemnify Council;
- (e) Revoking Local Law No. 6;
- (f) Providing for the administration of the Council's powers and functions.

This Local Law applies to roads and public carparks in defined parts of the Beechworth town area. It prohibits certain activities, and requires permits to be obtained for certain other activities:

Prohibited Activities

(a) No person shall distribute handbills to pedestrians or allow handbills to be distributed to pedestrians. This sub-clause does not apply to how-to-vote cards or other electoral material approved for use in a Commonwealth, State or Municipal Election.

(b) No person shall wear or carry or allow to be worn or carried any mobile advertising. This does not apply to mobile advertisements worn or carried as part of any festival or procession approved by council.

(c) No person shall place or keep or allow to be placed or kept in any milk crate, bread crate, box, basket or container of any type whatsoever between 8.00 a.m. and 8.00 p.m. except during the course of sending or receiving goods for a period not exceeding 30 minutes.

Permits Required

(a) No person shall place or keep or allow to be placed or kept an advertisement, goods or display or sale, a signboard, table, chair or umbrella without a permit.

(b) No person shall offer for sale or sell or allow to be offered for sale or sold any goods or services without a permit.

(c) No person shall use or play or allow to be used or played any musical or broadcasting equipment or loud-hailer for public entertainment or advertising purposes without a permit.

The Local Law prescribed forms and procedures for permit applications, and sets penalties for offences. It also sets out procedures for correcting, cancelling and amending permits and issuing infringement notices. Transitory provisions deal with permits and applications under Council's previous Local Law No. 6.

The Local Law comes into effect on 1 September 1993.

The Shire of Bungaree has prepared an amendment to the Bungaree Planning Scheme, Local Section.

The amendment has two main components—one to alter the maps and the other to alter the ordinance provisions.

The map changes adjust the Township zone boundaries in Wallace and Bungaree to more accurately reflect existing land use and subdivision and to better reflect land capability and other environmental constraints.

The major change to the Township zone provisions has been to prohibit any new subdivision unless the lots are provided with reticulated sewerage. Previously unsewered lots could be created provided they were over 0.4 ha in area. The new sewerage requirement is designed to limit the physical spread of the towns and yet allow for increased population without any increase in effluent disposal within the catchment.

The amendment can be inspected during office hours at Shire Offices, Western Highway, Leigh Creek; Department of Planning and Development, Central Highlands/Wimmera Region Office, corner Mair and Doveton Streets, Ballarat and the Department of Planning and Development, The Olderfleet Buildings, 477 Collins Street, Melbourne.

The Shire of Buninyong has prepared an amendment to the Buninyong Planning Scheme, Local Section, Chapter 1.

The amendment has two main components—one to alter the maps and the other to alter the ordinance provisions.

The map changes adjust the Township zone boundaries in Wallace and Bungaree and in most cases the Township zone boundary is expanded to increase the opportunities for residential development. In some areas the township boundaries have been reduced to better reflect land capability and other environmental constraints.

The major change to the Township zone provisions has been to prohibit any new subdivision unless the lots are provided with reticulated sewerage. Previously unsewered lots could be created provided they were over 0.4 ha in area. 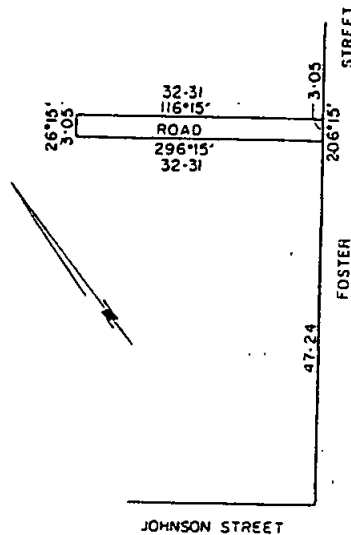
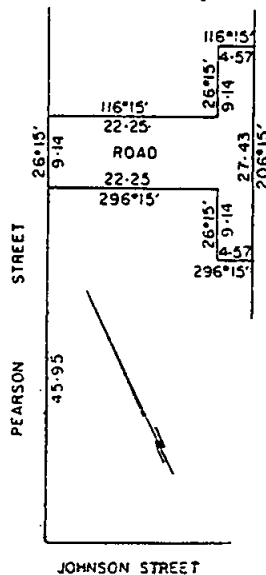

1. This Order is called the Appointment of the Leongatha Water Board Order 1993.

2. This Order is made under the powers conferred by Division 2 Part 6 of the *Water Act 1989* and all other available powers.

3. This Order takes effect on the date of its publication in the *Government Gazette*.

4. In this Order:

"Act" means *Water Act 1989*;

"Former Authority" means the Tarwin Valley Water Board;

"Constituting Order" means the Order constituting the Leongatha Water Board and abolishing the Leongatha Waterworks Trust and Leongatha Sewerage Authority published in the *Government Gazette* of 23 November 1983.

5. On and from the date on which this Order takes effect the Leongatha Water Board is appointed to take over the whole of the property, rights, liabilities, obligations, powers and functions under the Act of the Former Authority including the management and control of the existing water districts named below:

Tarwin Valley Urban District

Tarwin Valley Waterworks District

6. The Leongatha Water Board takes over the staff of the Former Authority from the date of this Order.

7. Clause 2.1 of the Constituting Order is amended by omitting Clause 2.1 and substituting the following paragraph:

- "(1A) The Board shall comprise—
- (a) seven members who shall be elected by persons whose names are enrolled on the voter's roll for the Leongatha Water Board Electoral District; and
 - (b) on and from the date of the next ordinary election of the Board in 1994, one member who shall be elected by persons whose names are enrolled on the voter's roll for the Tarwin Valley Electoral District.
- (1B) Members elected in accordance with clause (1A) (b) shall retire and be subject to re-election in successive years as follows—
- two in the first year;
 - two in the second year;
 - three in the third year.
- (1C) Until a member is elected in accordance with clause (1A) (b) the Minister may appoint a member to the Board.
- (1D) Mr Edward Francis Hanley is appointed as a member of the Board in accordance with clause (1C)."

8. Clause 2.K of the Constituting Order is amended by omitting Clause 2.K and substituting the following paragraph:

"K. The electoral districts of the Board shall be called—

- (a) the Leongatha Water Board Electoral District comprising the whole of the Leongatha Waterworks District; and
- (b) the Tarwin Valley Electoral District comprising the whole of the Tarwin Valley Urban District and the whole of the Tarwin Valley Waterworks District".

9. The former Authority is abolished.

10. (a) This is an Order referred to in section 98 (2) (a) of the Act.

(b) Under section 100 (2) (a) of the Act, the affected Authorities have applied to me for this Order to be made.

(c) Under section 98 (2) (a) of the Act, I have agreed to the terms and conditions with the Former Authority and the Leongatha Water Board.
