



**CITY OF FOOTSCRAY****Road (Right of Way) Discontinuance  
(File Ref.: 25/78/270)**

Whereas the Council of the City of Footscray has, pursuant to section 528 (2) of the *Local Government (Miscellaneous) Act 1958*, formed the opinion that the road (right of way) rear 179-183 Stephen Street, Yarraville is not reasonably required as a road (right of way) for public use and has, not less than one month before formally directing by resolution that the said road be discontinued, published a public notice in a newspaper generally circulating in the Municipal district and given written notice to the last registered owner of the land in the road

(right of way) and the owners and occupiers of lands abutting or immediately adjacent to the road (right of way) of the proposed discontinuance, and has considered all (if any) written submissions to the proposals.

Now therefore the Council of the City of Footscray by resolution on 12 November 1990, has directed that the said road (right of way) which is shown by hatching on the plan hereunder be discontinued and the land being the road (right of way) so discontinued shall vest in the Municipality until it is sold by private treaty.

**Proposed Local Law No. 3**

**Streets, Roads and Municipal Places**

The City of Mildura has drafted a Streets, Roads and Municipal Places Local Law for the purposes of:

- (a) Provision and control for the management of traffic, use of roads by persons, vehicles and animals and to regulate the parking of vehicles for the

safety and fair use by people in the municipal district;

- (b) Provision for the peace, order and well being of people in the municipal district;
- (c) Provision for the physical features of the road and adjacent properties to be managed in a way which attends to the safety and convenience of people travelling on or using the road (whether on foot or by vehicle);
- (d) (i) The controlling of various types of vehicles and animals for the safety and convenience of road users;
- (ii) The preservation and protection as far as possible of the Council's assets from damage which may be caused from extra ordinary use of streets and roads within the municipal district;
- (iii) Controlling and protection of road reservations from horses in built up areas;
- (iv) Regulating the parking of heavy vehicles on properties in residential areas;
- (e) (i) Controlling and regulating secondary activities on roads including—
  - (i) trading;
  - (ii) placing of goods and equipment;
  - (iii) repairs to vehicles;
  - (iv) parties, festivals and processions—

in a fair, equitable and safe manner which does not compromise the primary need for the passage and repassage of people and goods;
- (ii) The provision of free and safe access for people with sight and movement impairment or disabilities;
- (f) (i) The provision for the safe and efficient management and control of parking on roads in the municipal district;
- (ii) The provision of mechanisms to manage and control parking so as to cause minimal disruption, danger or nuisance to the users of Council's parking facilities;

- (g) (i) Allowing and protecting the quiet enjoyment by people of municipal places within the municipal district;
- (ii) Enabling people in the municipal district to carry out their day to day activities and to enjoy their recreational pursuits without having their peace and enjoyment interfered with or destroyed;
- (iii) Recognising and responding to community expectations relating to the quality of life they expect and require and are capable of influencing;
- (iv) Controlling and prevention of behaviour which is a nuisance, or which may be detrimental to health and safety or which effects the enjoyment of recreational or other facilities;
- (v) Enabling the community and visitors and their families who use municipal places that are available to the public to be confident in their choice of the use of those facilities or places;
- (vi) Protection of Council and community assets and facilities on or in municipal places;
- (vii) In a way which is consistent with, and in furtherance of, the objectives specified in paragraphs (a) to (f) of this clause, to prohibit, regulate and control—
  - (i) Behaviour in municipal places which is boisterous or harmful or intimidating;
  - (ii) Behaviour in municipal places which is offensive, dangerous or threatening, or for which, for other reasons, is inappropriate in a municipal place—
- (viii) Regulating and controlling behaviour in the Mildura Olympic Swimming Pool Centre.

2.2 The rear overhang of the motor vehicle and any load (as defined in the Road Safety (Vehicles) Regulations 1988) must not exceed the lesser of 3.7 metres or 60% of the distance between the centre of the front axle and the overhang line (as defined in the Road Safety (Vehicles) Regulations 1988).

2.3 This permit may be used in conjunction with:

- (a) General Mass and Dimension Permit Agricultural Machines and Agricultural Implements, Authorised Multiple Articulations, Rigid Vehicle Towing an Agricultural Implement, Vehicle and Trailer Combinations (Gazette No. S33, 13 June 1991); and
- (b) General Dimension Permit for Over Length Motor Vehicle and Trailer Combinations (Gazette No. G3, 21 January 1993).

##### Part 3—Specified Highways

3.1 The vehicles specified are authorised to undertake journeys on a State highway, a main

road, a tourists' road, a forest road and a freeway (as defined in section 2 (1) of the *Transport Act* 1983) and over highways between those highways.

Part 4—Specified Conditions

4.1 Owners of rigid motor vehicles that exceed 11 metres in length shall ensure that any drivers of these vehicles are aware that they are driving a longer vehicle which may not be able to access some minor roads.

4.2 Travel is not permitted on a highway where any sign posted dimension limit would be exceeded.






