Notice of Proposed Local Law No. 5A—Public Area

To Amend Public Area Local Law No. 5

Notice is hereby given in accordance with section 119 of the *Local Government Act 1989* that the Council of the City of Croydon at its meeting held on 4 October 1993 resolved its intention to make Public Area Local Law No. 5A to amend the existing Public Area Local Law No. 5—October 1992.

The objective of this Local Law is to amend the existing City of Croydon Local Law No. 5 Public Area Local Law by adding clauses relating to:

*Advertising Signs (Movable) Placed on Roads*

- (a) No person may without a permit and the payment of the prescribed fee erect or place any advertising sign on any part of a footpath, road or Council land or public place or cause or authorise another person to do so except if a person is the holder of an appropriate permit issued by the Council.
- (b) No person without a permit shall write, print, stencil, place or affix any letter, figure, device, poster, sign or advertisement upon any footpath, street or road or upon any building, fence or other property vested in the Council or under the control of management of the Council or any other public place.
- (c) Advertising signs on vehicles: No person may park or leave standing or employ or contract with a person to park or leave standing on a road or public place a vehicle or trailer used primarily for the purpose of advertising without a permit.

*Animal Droppings*

Any owner or any other person for the time being in charge or control of an animal who fails to collect and properly dispose of any animal droppings deposited by that animal on any Council land or road/street or public place is guilty of an offence. An owner in relation to any dog shall include a person who keeps or harbours the dog or has the dog in his or her care for the time being whether the dog is at large or in confinement.

*Removal of Graffiti*

By the addition of Clause (c) to the existing Clause 12.11 (a) and (b).

- (c) No person shall apply or spray graffiti to any land, buildings, fences, walls, objects or the like, without a permit from the Council.

The proposed Local Law contains regulations and controls which meet these objectives. It also requires permits for certain activities. The Local Law also provides for penalties for non-compliance.

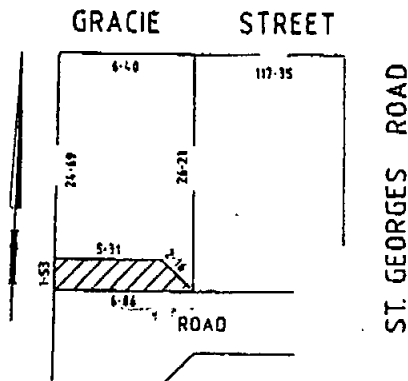

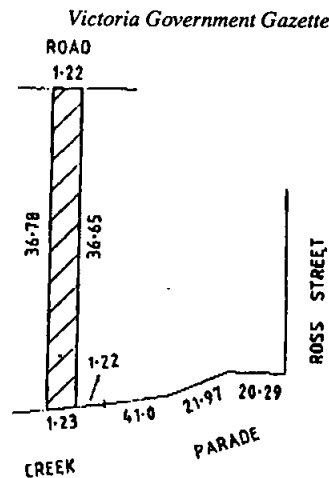

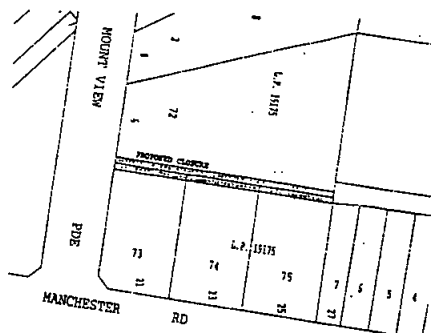

- (a) the manufacturer's load rating for the tyre; or
- (b) in the case of—
  - (i) a wide profile tyre (not less than 375 millimetres wide) on a non-steering single axle—3.85 tonnes; or
  - (ii) for any other tyre—3.20 tonnes, whichever is the lesser.

*Axles and Axle Groups*

3.2 The load on any axle or axle group must not exceed the limits specified by the manufacturer, or the limit referred to in clause 3.3 or 3.4, whichever is the lesser.

3.3 The load on an axle group without a load sharing suspension system (other than a twin steer axle group) or on a trailer with only a single axle or axle group (pig trailer) must not exceed the mass limits specified in regulations 705 to 713 of the Road Safety (Vehicles) Regulations 1988.

3.4 The load on an axle, or on an axle group with a load sharing suspension system, must not exceed the applicable mass limits set out in the following table:

*Gross Mass*

- (c) any manufacturer's mass limits.

The gross mass of a trailer (other than a semi-trailer) must not exceed the gross mass of the towing motor vehicle.
