





- (1) regulate the identification of premises;
- (m) regulate the growth of trees and plants so as to prevent accidents;
- (n) prohibit obstructions; and
- (o) provide for the construction and maintenance of permanent and temporary vehicle crossings.

The purpose and purport of this Local Law is to prevent the growth of prohibited plants in the municipal district.

Local Law No. 14 Fees and Services

The purpose and purport of this Local Law is to provide for the performance of services, and the fixing of fees.

Local Law No. 22 Access to Information

The purpose and purport of this Local Law is to:

- (a) promote the principles of accountability, openness accessibility by providing access to information;
- (b) promote and encourage the flow of information in the possession of Council:
- (c) promote and assist the accuracy and reliability of information kept by Council;
- (d) provide a simple system so members of the community can access information kept by Council;
- (e) provide generally for the peace, order and good government of the municipal district;
- (f) provide for the administration of council's powers and functions.



SHIRE OF BRIGHT PROPOSED LOCAL **LAWS**

In accordance with section 19 of the Local Government Act 1989, the Shire of Bright gives notice of its intention to make the following Local Laws.

Local Law No. 14

SHIRE OF BUNINYONG Camping, Caravan and Temporary Dwelling Local Law Local Law No. 7


