**Local Law No. 4—Environment Local Law
Amendment**

The purpose of the amendments is to make the following changes:

- (a) Objectives of Local Law No. 4—add to Clause L1.2—
“(h) to compliment the Victoria Building Regulations 1983 and the Building Code of Australia 1990 by adopting siting

requirements for class 1, 2 and 10 buildings in excess of those specified in Table 11.6 of the Victoria Building Regulations."

- (c) PART 6—THE ENVIRONMENT
"6.4 BUILDING SITING (New
Clause)

- (1) No person may erect or cause to be erected any building or extension to an existing building except in accordance with the Victoria Building Regulations and this Local Law.
- (2) For the purpose of Table 11.6 of the Victoria Building Regulations the Council of the City of Sale hereby adopts the following siting requirements in respect of any class 1, 2 and 10 buildings:

Width of frontage—16.5 metres
Depth of allotment—27 metres
Area of allotment—650 square metres

Set back from frontage—6 metres
Set back from any other street
alignment—2 metres
Set back from any other
boundary—1.8 metres

A reduced set back from a side boundary for additions to dwellings that have been legally constructed at an offset of 1.2 metres prior to this Local Law coming into effect—1.2 metres.

- (3) Any person may apply to Council to vary siting requirements referred to in 6.4 (2)."



SOAKS RESERVE

Title

1. These Regulations may be cited as the Soaks Reserve Regulations 1993.

Objectives

2. The objective of these Regulations is to provide for the care, protection and management of Crown Allotment 72, Parish of Eureka temporarily reserved for the conservation of an area of natural and historic interest by Order in Council of 8 September 1992 (hereinafter called "the Reserve").

Authorising provision

3. These Regulations are made under section 13 of the *Crown Land (Reserves) Act 1978*.

Commencement

4. These Regulations come into operation on the date on which they are published in the *Victoria Government Gazette*.

Regulations

5. The Reserve shall be open to the public at all times free of charge.

6. Within the Reserve a person must not—

- (a) enter or remain who may offend against decency as regards dress, language or conduct or who may behave in a disorderly, unseemly or offensive manner, or create or take part in any disturbance;
- (b) carry, use or discharge any firearm, air rifle or any other weapon;
- (c) carry or use any trap, snare, net or other device for the capture of animals;
- (d) disturb, interfere with or destroy any animal or bird or its lair or nest;
- (e) interfere with, mark, deface or damage any buildings, gates, fences, barriers, seats, signs or any other improvements;
- (f) deposit any litter except in receptacles provided for the purpose;
- (g) erect buildings, nor sell or offer to sell or hire any article or commodity;
- (h) permit any dog unless such dog is at all times controlled by a chain, cord or leash; or
- (i) excavate, remove, damage or interfere with any archaeological or aboriginal remains or relic.

7. Within the Reserve a person must not, unless authorised in writing by the Regional Manager, Department of Conservation and Natural Resources, Mildura—

- (a) interfere with, mark, deface, damage, pick or injure any tree, shrub, flower, plant or any other vegetation;
- (b) light or cause to be lit any fire except in any properly constructed fireplace provided for that purpose;
- (c) camp;
- (d) drive any vehicle other than on a formed road or car park open to the public;
- (e) put or allow to remain any sheep, horses, cattle, pigs or other animals;
- (f) organise or take part in any public entertainment game or sport;
- (g) disturb or remove any soil, sand, humus, gravel or rock.

8. Every person who contravenes or fails to comply with these Regulations shall be guilty of an offence and liable to the penalties prescribed
