Wildlife Act 1975

NOTICE OF CLOSURE OF AREAS TO HUNTING

I give notice under section 86 of the *Wildlife Act 1975*, that—

- (a) the taking, destroying or hunting of any kind or species of wildlife is prohibited—
 - (i) in the area described in Schedule 1 during the period specified in that Schedule; and
 - (ii) in the areas described in Schedule 2 during the period specified in that Schedule; and
- (b) a person who takes, destroys or hunts any kind or species of wildlife in an area specified in Schedules 1 or 2 during the periods specified in those Schedules is guilty of an offence and liable to a penalty not exceeding 25 penalty units.

SCHEDULE 1

Area: The area within 500 metres of the Wool Wool Rocks being the rocks near the shore of that part of Lake Corangamite, which forms the boundary between the Shires of Colac and Hampden.

Period: The period commencing on Saturday, 19 March 1994 until further notice.

SCHEDULE 2

Areas: The following areas within the Lake Connearwarre State Game Reserve, Shire of Barwon—

- (a) the Phragmites/cumbungi reed bed situated in the south western corner of Reedy Lake south-south-west of the "big hole" and indicated by heavy border on the plan hereunder;
- (b) that part of Lake Connearwarre and adjoining land shown by heavy border on the plan hereunder.

Period: The period commencing on Saturday, 19 March 1994 until further notice.
