I, Sir John McIntosh Young, Deputy Governor of Victoria declare that I have today assented in Her Majesty's name to the following Bill:

No. 37/1994 Gaming and Betting Act

No. 37/1994 (1) Part 1 comes into operation on the day on which this Act receives the Royal Assent.

(2) Subject to sub-section (3), the remaining provisions of this Act come into operation on a day or days to be proclaimed.

(3) If a provision referred to in sub-section (2) does not come into operation within the period of 12 months beginning on, and including, the day on which this Act receives the Royal Assent, it comes into operation on the first day after the end of that period.

State Owned Enterprises Act 1992

The proposed Order declares under the State Owned Enterprises Act 1992 that State Trustees Limited is a State owned company.

On 1 July 1994 it is proposed to transfer the assets and liabilities of the State Trust Corporation to State Trustees Limited, a new company which is wholly owned by the State.

The State Trustees (State Owned Company) Bill, recently passed by Parliament will facilitate this process.

State Trustees Limited will be—

a company under the Corporations Law of Victoria; and

a trustee company under the Trustee Companies Act 1984; and

be able to provide services to the community under agreements with the Minister.

Declaration of State Trustees Limited as a State owned company under the State Owned Enterprises Act 1992 will result in it being subject to Part 5 of the State Owned Enterprises Act 1992 which, inter alia, provides for the financial statements and reports of the company to be laid before Parliament.
