Water Act 1989

I, Charles Geoffrey Coleman, as Minister administering the Water Act 1989, make the following Order:

CONSTITUTION OF THE HORSHAM WATER BOARD ORDER 1994

Citation

1. This Order is called the Constitution of the Horsham Water Board Order 1994.

Enabling Powers

2. This Order is made under the powers conferred by Division 2 of Part 6 of the Water Act 1989 and all other available powers.

Date of Effect

3. This Order takes effect on and from 3 October 1994.

Definitions

4. In this Order:

"Act" means the Water Act 1989.

"Former Authority" means the City of Horsham constituted by an Order in Council dated 20 September 1983 and published in the Government Gazette on 21 September 1983.

Constitution of New Authority

- 5. On and from the date on which this Order takes effect:
 - (a) there is constituted a new Authority; and
 - (b) the corporate name of the new Authority is the Horsham Water Board.

Takeover of the City of Horsham

- 6. On and from the date on which this Order takes effect the new Authority constituted by Clause 5 of this Order takes over:
 - (a) the whole of the property, rights, liabilities, obligations, powers and functions under the Act of the Former

Authority including the management and control of the existing water districts named below:

Horsham Waterworks District; Horsham Urban Water District; and the management and control of the existing sewerage district named below: Horsham Sewerage District.

7. The Horsham Water Board takes over the staff of the Former Authority listed below:
