Public Holidays Act 1993
CITY OF BALLARAT

Sub-section 7 (1) (b) of the **Public Holidays Act 1993** ("the Act") allows non-metropolitan Councils to appoint one day or two half days annually as public holidays within the municipal district.

Pursuant to sub-section 7 (3) of the Act a notice published under sub-section 7 (1) (b) must be published not less than 6 months before the day appointed or within any shorter period approved by the Minister. By written notice dated 7 October 1994, the Minister for Industry Services the Honourable Roger Pescott, advised the City of Ballarat that he is satisfied that special circumstances exist and he has shortened the notice period to not less than 4 weeks before the appointed day.

Notice is given that the Council of the City of Ballarat has appointed Wednesday, 16 November 1994, being Ballarat Cup Day, as a public holiday throughout the municipal district of the City of Ballarat.
