#### Summer Time Act 1972 PROCLAMATION

Substitution of Period of Summer Time

- I, Richard E. McGarvie, Governor of Victoria, under section 3 of the Summer Time Act 1972, revoke the proclamation of 9 October 1990 made under the Act and substitute it with the following proclamation:
  - The period of summer time shall commence at the hour of two o'clock in the morning of the last Sunday in October in each year and end at the hour of two o'clock in the morning of the last Sunday in March in the following year.
  - For the purposes of this proclamation the expression "in the hour of two o'clock in the morning" means that hour as determined by standard time.

The amendment enables limited subdivision, subject to planning permit approval, where the land was purchased prior to 1978 and has been in continual ownership. The subdivision must satisfactority meet certain performance criteria and be subject to a land management

plan.

Overlay controls have been introduced which apply in addition to the zoning requirements. The sites with overlay controls were identified as Sites of Significance within the 'Environmental Studies East of Multium Multium Creek - Sites of Botanical and Zoological Significance 'Ecological Horticulture and Gemer and Sanderson (1992). The overlay controls provide specific guidelines to ensure that any development which takes place within the relevant area is in keeping with the environmental and visual character of the area. This amendment refers to Sites of Significance within the proposed Landscape Interest Zone. A future amendment will deal with other Sites of Significance in other zones.

  - (iii) fire hazards; and

  - (v) swimming pools; and
  - (vi) advertising, bill posting and junk mail; and
  - (vii) camping and temporary dwellings; and
  - (viii) circuses, carnivals and festivals;and
  - (ix) quarrying; and

- (x) water quality, including interference with water courses; and
- (xi) animals, including animals numbers and the keeping and control of animals; and
- (xii) disposal of waste including behaviour associated with trips; and
- (xiii) building control;
- (f) to provide for the peace order and good government of the municipal district; and

- 2. Local Law No. 3—Municipal Places Local Law

- (a) to allow and protect the quiet enjoyment by people of municipal places within the municipal district;
- (b) to enable people in the municipal district to carry out their day to day activities and to enjoy their recreational pursuits without having their peace and enjoyment interfered with or destroyed; and
- (c) to recognise and respond to community expectations relating to the quality of life they expect and require and are capable of influencing; and
- (d) to control and prevent behaviour which is a nuisance, or which may be detrimental to health and safety or which affects the enjoyment of recreational or other facilities; and
- (e) to enable the community and visitors and their families who use municipal places that are available to the public to be confident in their choice of the use of those facilities or places; and
- (f) to protect Council and community assets and facilities on or in municipal places; and
- (g) in a way which is consistent with, and in furtherance of, the objectives specified in paragraphs (a) to (f) of this clause to prohibit, regulate and control—
  - (i) behaviour in municipal places which is boisterous, harmful or intimidating;

- (ii) behaviour in municipal places which is offensive, dangerous or threatening or which, for other reasons, is inappropriate in a municipal place;
- (h) to provide generally for the peace, order and good government of the municipal district; and
- to provide for the administration of the council's powers and functions.
- 3. Local Law No. 4—Streets and Roads Local Law

The purposes of this Local Law are:

- (a) to provide and control for the management of traffic, use of roads by persons, vehicles and animals and to regulate the parking of vehicles for the safety and fair use by people in the municipal district;
- (b) to provide for the peace, order and well being of people in the municipal district;
- (c) in Part 5-
  - (i) to provide for the physical features
     of the road and adjacent properties
     to be managed in a way which
     attends to the safety and
     convenience of people travelling
     on or using the road (whether on
     foot or by vehicle);
  - (ii) to establish mechanisms for adequate consultation to accompany major changes to traffic arrangements and the discontinuation of roads; and
- (d) in Part 6-
  - (i) to control various types of vehicles and animals for the safety and convenience of road users;
  - (ii) to preserve and protect as far as possible the Council's assets from damage which may be caused from extraordinary use of streets and roads within the municipal district; and
- (e) in Part 7-
  - (i) to control and regulate secondary activities on roads including—
  - (ii) trading;
  - (iii) the placing of goods and equipment;
  - (iv) repairs to vehicles; and
  - (v) parties, festivals and processions-

in a fair, equitable and safe manner which does not compromise the primary need for the passage and repassage of people and goods.

The proposed Local Laws contain regulations and controls which meet these objectives. It also requires permits for certain activities and lists standards to assist Council in determining whether or not to grant such permits. Finally, the Local Laws provide for penalties for non-compliance.

Part 6—regulate the proceedings at meetings of the Council and committees and, in particular, establishes quorums, adjournment procedures states meeting times, provides for notice of meetings, the order of business, motion and resolution debate procedures, keeping of minutes, handling of correspondence and petitions, provisions for deputations, citizens question time, appointment of committees, suspension of regulations and councillors.

Part 7—describes offences and sets penalties.




