VICTORIA The Act No. 391 Amendment Act 1925 First Schedule

Whereas by virtue of the powers conferred by the Act of the Parliament of Victoria Numbered 391, the Administrator on 21 October 1875 allowed an Application for leave to dispose of the land described in the said allowance:

Now therefore I, Keith Rayner, Archbishop of Melbourne, Head or authorised representative of the denomination known as the Anglican Church of Australia within the Diocese of Melbourne with the consent of Melbourne Anglican Trust Corporation, the trustee of the said land so far as undisposed of pursuant to the said allowance (and of the proceeds of disposition so far as the said land has been disposed of) and of James Alexander Grant, Dean of Melbourne, being the person entitled to minister in or occupy a building upon so much of the said land as has not been disposed of pursuant to the said allowance (and to receive the income derivable from investment of any proceeds of dispositions pursuant to the said allowance), do hereby apply to the Governor of the State of Victoria to amend or vary the said allowance in manner hereinafter mentioned:

that the only trustee of the land (and of the proceeds of disposition so far as the said land has been disposed of pursuant to the said allowance) resident in Victoria is the said Melbourne Anglican Trust Corporation;

that the only building upon the land undisposed of pursuant to the said allowance is The Deanery, East Melbourne and that the only person entitled to minister in or occupy the same is the said James Alexander Grant, Dean of Melbourne.

Existing Statement of Trusts:

Description of Land: Allotments 4, 5, 14 and 15, section 13, County of Bourke, Parish of North Melbourne, at East Melbourne.

Power of Disposition: Power to sell or let, subject to the approval of the Bishop or, during the absence of the Bishop from the diocese or the vacancy of see, of the person for the time being administering the affairs of the diocese and of the person for the time being holding the office of Dean of Melbourne. The Bishop, or the person administering the affairs of the diocese,

to have power to remove trustees and to appoint new trustees, and to fill up all vacancies occurring in trusteeship. The land and building to be held until otherwise disposed of for the use of the person holding for the time being the office of Dean of Melbourne. No approvals to be given or powers to be exercised without the advice of the Council of the Diocese.

Purposes for which proceeds of disposition are to be applied: Rents obtained from leases to be applied to payment of costs and expenses connected with execution of trusts, of all charges on the property and of costs of keeping premises insured and in substantial ornamental repair, so far as such charges and costs shall not have been otherwise provided for. Balance of rents to be paid from time to time to the person holding for the time being the office of Dean of Melbourne, for his own use or, if there be no such person, to the Bishop, or, during the vacancy of the see, to the person for the time being administering the affairs of the diocese. To be invested or applied in such manner as the Bishop, or such person administering the affairs of the diocese, shall think best for the benefit of the person holding for the time being the office of Dean of Melbourne. Premiums on leases or proceeds of sales to be invested, with approval as aforesaid, in Government debentures, or in mortgage of real estate in Victoria, or in the purchase of land with buildings thereon and in the erection of buildings thereon. The income derivable from such investment to be applied in the same manner as rents derived from leases; the trustees having power to alter or vary investments with approval as aforesaid; all substituted investments being subject to same trusts as those herein set forth. Persons dealing with trustees not to be bound to see to the application of moneys paid to the trustees by them.

Statement of Amendments or Variations of Existing Statement of Trusts hereby applied for: Power of Disposition: No amendment or variation proposed.

Purposes to which proceeds of dispositions are to be applied: That the Statement of Purposes set out above be amended or varied—

by omitting the passage beginning "Balance of rents" and ending "Dean of Melbourne." (where secondly occurring) and inserting in its place the passage "Balance of the rents to be paid from time to time to the Cathedral Chapter to

be applied first, towards the provision and maintenance of a residence for the Dean of Melbourne, secondly, towards the payment of the stipend and allowances and other emoluments of the Dean of Melbourne and thirdly towards such other purposes of St Paul's Cathedral, Melbourne as the Cathedral Chapter, the Bishop, or person administering the affairs of the diocese, and the Dean of Melbourne approve."; and

by omitting the words "or in the purchase of land and in the erection of buildings thereon" and inserting in their place the words "in the purchase of land and in the erection of buildings thereon, or in any other manner of investment which Melbourne Anglican Trust Corporation is authorised to make under any Act of the Synod of the Diocese of Melbourne regulating the powers of investment of the said Melbourne Anglican Trust Corporation."








