

# Employee Relations Act 1992 MINISTERIAL REFERENCE NOMINATION OF INDUSTRY SECTORS

On Tuesday, 9 August 1994, the Minister for Industry and Employment, the Honourable Phillip Gude MP announced a number of changes to the Victorian employee relations framework.

By letter dated 9 September 1994 the Minister referred a number of matters to the Employee Relations Commission of Victoria. The letter states (in part):

"The Government has announced that the 238 expired awards and the Victorian Public Service Determinations and Regulations, will be abolished and consolidated into 10-15 Industry Sectors.

It is envisaged that the Industry Sectors will include work classifications and minimum rates of pay applicable to employees covered by the Sector. Ideally, each Industry Sector will contain between one and six classifications. The minimum wage will represent a base rate of pay exclusive of loadings and allowances except loadings paid to compensate workers for the casual or piece rate nature of their employment.

The Industry Sectors, work classifications and minimum wages will initially be set by the Commission on the authorisation of the Minister pursuant to a Section 113 Ministerial Reference.

Thereafter, the Commission will be empowered to set and adjust the minimum wages by compulsory arbitration on the application of an employee, employer or recognised association or employees or employers or pursuant to a Section 113 Ministerial Reference."

The Commission has been requested to provide the Minister with a report nominating a small number of Industry Sectors by Friday, 7 October 1994.

The President has referred the matter to the Commission in Full Session comprising President Zeitz, Deputy President Garlick, Deputy President Lane, Commissioner Pimm and Commissioner Hastings. The Commission


