WATER ACT 1989

I, Charles Geoffrey Coleman, as Minister administering the Water Act 1989, make the following Order:

Amendment to the Constitution of the Hopkins Region Water Authority Order 1994 No. 2

Citation

1. This Order is called the Amendment to the Constitution of the Hopkins Region Water Authority Order 1994 No. 2.

Enabling Powers

2. This Order is made under the powers conferred by Division 2 of Part 6 of the Water Act 1989 and all other available powers.

Date of Effect

3. This Order takes effect on the date on which it is published in the Government Gazette.

Interpretation

4. In this Order the "Constituting Order" means the Order under the Water Act 1989 published in the Government Gazette No. S 40 of 29 June 1994 which constituted the Hopkins Region Water Authority.

Change to Name

5. On and from the date on which this Order takes effect, the corporate name of the Hopkins Region Water Authority as constituted under the Constituting Order is changed to the "South West Water Authority".

Pre-requisites for Making this Order

6. (a) This is an Order referred to in Section 99 (8) (a) of the Water Act 1989.
- (b) The Hopkins Region Water Authority has applied to me for this Order to made.
