Planning and Environment Act 1987 WARRNAMBOOL PLANNING SCHEME Local Section—Chapter Two Notice of Amendment to a Planning Scheme Amendment L10

The Warrnambool City Council has prepared Amendment L10 to the Warrnambool Planning Scheme.

The amendment affects land at:

Item One: Shop 2, No. 1051 Raglan Parade, Warrnambool.

Item Two: Nos 82-84 Raglan Parade, Warrnambool.

The amendment proposes to change the Planning Scheme by:

Item One: Allowing the premises to be used as a video hire shop.

Item Two: Extending the existing Commercial 2 zone a further 9m to the north.

CITY OF MELBOURNE Notice of Proposed Local Law Consumption of Liquor on Roads and Public Places (Amendment) Local Law 1995

On 20 January 1994 the Council of the City of Melbourne made a Local Law entitled "Consumption of Liquor on Roads and Public Places Local Law" (No. 3 of 1994) (the Principal Local Law). The objectives of the Local Law were to regulate and control the consumption of liquor and possession of liquor other than in a sealed container on a road, in or at a public place; or in or on a stationary vehicle between the hours of 7 p.m. each day and 8 a.m. the next day in the area bounded by and including Flinders Street, Spring Street, La Trobe Street and Spencer Street, including the area known as Banana Alley ("the City Grid area").

Council resolved on 19 September 1995 to amend the Principal Local Law by increasing the minimum fine and changing the geographical boundaries of the Local Law for the periods during which special events are taking place (that is, Moomba, the Grand Prix and New Year festivities). Submissions received with respect to the proposed amendment to the Principal Local Law were considered by Council and as a result Council resolved on 14 November 1995 to modify the proposed amendment to the Principal Local Law.

The proposed amendment to the Principal Local Law is entitled "Consumption of Liquor on Roads and Public Places (Amendment) Local Law 1995" (No. 2 of 1995). The objectives of the amendment are:

- (a) to provide for a 24 hour a day control over the consumption of liquor on roads and public places during the periods specified in amended Clause 4 (1) (b); to extend the area to which the 24 hour a day control applies; to increase fixed penalties and to amend the offence provisions under the Principal Local Law; and
- (b) to make consequential amendments to the Principal Local Law.

The aim of the amendment is to appropriately regulate behaviour in the municipal district during designated special events when there is influx of people into the Municipality with a view to consideration of the welfare of the whole community.

The extended area is that area bounded by, to the north, Flinders Street from Spencer Street to Swanston Street and then to the north and east the Yarra River from Princes Bridge to Swan Street Bridge; to the south, Spencer and Clarendon Streets to the Westgate Freeway intersection, and then Kingsway from the Westgate Freeway to Dorcas Street; to the south, Dorcas Street from Kingsway to St Kilda Road and Linlithgow Avenue from St Kilda Road to Alexandra Avenue; to the east, Swanston Street from Flinders Street to Princes Bridge and then the Yarra River banks, the Alexandra Gardens and the Queen Victoria Gardens.

Clause 4 of the Principal Local Law is substituted to provide that the current arrangements for the "City Grid" area remain in place; that a 24 hours a day control over the consumption of liquor be put in place with respect to the City Grid area and the extended area during the designated special event periods of Moomba, the Grand Prix and New Year festivities. The penalty for breaching a provision of the Local Law is increased from \$50 to \$100.

Any person affected by the proposed local law may make a submission relating to it under Section 223 of the **Local Government Act 1989**. Submissions should be addressed to the Manager Secretariat, Town Hall, Swanston Street Walk, Melbourne 3000 and must be received by the Council within 21 days of this Notice. Any person making a written submission should clearly state whether they wish to be heard in support of their submission.
