**(OPERATION OF FLOODLIGHTS) ORDER**  
No. 1/1995

I, Mark Alexander Birrell, Minister for Conservation and Environment, make the following Order:

*Title*

1. This Order may be cited as the Melbourne Cricket Ground (Operation of Floodlights) Order No. 1/1995.

*Objective*

2. The objective of this Order is to—
- specify the days and times during which the floodlights affixed to the floodlight towers at the Melbourne Cricket Ground may be operated; and
  - specify the purposes for which the floodlights may be operated on those days; and
  - make provision in relation to vehicle entry and exit to and from the Yarra Park Reserve.

*Authorising provision*

3. This Order is made under section 3 of the **Melbourne Cricket Ground Act 1984**.

*Floodlights may be operated on certain days, times and for certain purposes*

4. The floodlights affixed to the floodlight towers at the Melbourne Cricket Ground may be operated—

- for the purpose of any activity conducted on the arena at the Melbourne Cricket Ground, between 10.00 a.m. and 8.00 p.m. on any day, including those specified in sub-clauses (b), (c) and (d); and
- for the purpose of playing cricket on the arena, at any time after 8.00 p.m. on the following days—  
13, 14, 15 and 16 December 1995;  
19 December 1995;  
9 January 1996;  
16 January 1996;  
18 January 1996;  
2 February 1996;  
13, 14, 15 and 16 February 1996;  
15, 16, 17 and 18 March 1996;  
21 March 1996;  
24, 25, 26 and 27 March 1996;  
30 and 31 March 1996;  
1, 2, 3 and 4 April 1996; and
- for the purpose of playing Australian Football League matches, at any time after 8.00 p.m. on the following days—  
29 March 1996;  
3 May 1996;  
8 May 1996;  
10 May 1996;  
24 May 1996;  
27 May 1996;  
7 June 1996;  
15 June 1996;  
21 June 1996;  
28 June 1996;  
5 July 1996;  
19 July 1996;  
26 July 1996;  
2 August 1996;  
16 August 1996;  
23 August 1996;  
30 August 1996;  
31 August 1996; and
- for the purpose of playing Australian Football League finals series matches, at any time after 8.00 p.m. on the following days—  
6 September 1996;  
13 September 1996; and

- (e) for the purpose of aligning, testing, commissioning or repairing of the floodlights, between 8 a.m. and 10 p.m. on any day.

*Yarra Park Reserve—entry and exit of vehicles*

5. On any day on which the floodlights affixed to the floodlight towers at the Melbourne Cricket Ground are permitted to be used for the purposes specified in clause 4 (b), (c) and (d), vehicular traffic is not permitted to enter into or exit from the Yarra Park Reserve by way of Vale Street after 5 p.m.
