TEST DRIVE—MOUNT BUFFALO ROAD

Notice of Decision

I, Vin Heffernan, Minister for Small Business give notice under section 12 of the **Subordinate Legislation Act 1994**, that I have decided that the proposed Trade Measurement Regulations 1995 be made.

A Regulatory Impact Statement was prepared and advertised inviting public comment and submissions. Several amendments have been made in response to some of the comments received. The certification fee for weighing instruments up to and including 30kg, Area Measuring Instruments, Length Measuring Instruments and Control systems connected to driveway flowmeters has been reduced from \$35 to \$25.

Trade Measurement Victoria will continue to provide verification of farm milk tanks and charge the current verification fee of \$8.70 for each 100 litres or part thereof until a firm(s) has become licensed to provide certification services to the dairy industry.
