Health Services Act 1988 THE APPOINTMENT OF AN ADMINISTRATOR TO HAMILTON BASE HOSPITAL

The Governor in Council, on the recommendation of the Minister for Health under section 61 (2) of the **Health Services Act 1988**, by this Order—

1. Appoints Richard Dennis Walter ("the administrator") of French Street, Hamilton, to be the administrator of Hamilton Base Hospital ("the hospital").

2. Specifies that this Order shall take effect from the date of this Order and shall remain in effect for six months from that date.
3. Specifies that the administrator shall be paid \$30,000 per annum.
