Country Fire Authority Act 1958 VARIATION OF FIRE DANGER PERIOD

In pursuance of the powers conferred by section 4 of the Country Fire Authority Act 1958, I, Leonard Raymond Foster, Chairman of the Country Fire Authority, after consultation with the Secretary of Conservation and Natural Resources, hereby dary the declaration of the Fire Danger Periods previously published in the Government Gazette by declaring that such Fire Danger Periods shall end in respect of the andermentioned Municipalities or parts of Innicipalities specified.

To terminate from 0100 hours on Monday, 10 April 1995:

Shire of Campaspe (Part). That part south of line created by the Goulburn River, Cattanach Canal, southern shore of Waranga Pasin, Waranga Western Channel, Goornong Murchison Road to Campaspe River.

Shire of Strathbogie (Part). That part south of the Hume Freeway and that part west of the Foulburn River.

Forests Act 1958, No. 6254 REVOCATION OF PROHIBITED PERIODS

In pursuance of the powers conferred by section 3 subsection (2) of the Forests Act 1958, I, Roderic Alan Incoll, delegated officer for Her Majesty's Minister for Natural Resources in the State of Victoria, hereby revoke the Prohibited Period in respect to the fires protected areas (other than State Forest, National Park and Protected Public Land) in the areas that, at the time of revocation, comprise or comprised the municipal districts of the municipalities listed below, or where part of a municipality is listed below, the area that, at the time of declaration, comprised part of the municipality nominated in the schedules hereunder:

SCHEDULE 1

The Prohibited Period shall end at 0100 hours on Monday, 10 April 1995 in the following municipalities:

Shire of Strathbogie—That part south of the Hume Freeway and west of the Goulburn River.
