FISHERIES NOTICE No. 4/1995

I, Charles Geoffrey Coleman, Minister for Natural Resources, after consultation with the Victorian Fishing Industry Federation, make the following Fisheries Notice:

FISHERIES (SCALLOP FISHING—PORT PHILLIP BAY FISHERY) (CLOSE SEASON) NOTICE No. 4/1995

Title

1. This Notice may be cited as the Fisheries (Scallop Fishing—Port Phillip Bay Fishery) (Close Season) Notice No. 4/1995.

Objective

2. The objective of this Notice is to fix a close season on the taking of scallops from Port Phillip Bay by prohibiting the taking of scallops or the use of any scallop dredge.

Commencement

3. This Notice commences on 21 January 1995.

Authorising Provision

4. This Notice is made under section 80 of the Fisheries Act 1968.

Close Season

5. (1) A person must not during the period commencing on 21 January 1995 and ending on 20 April 1995—

- (a) use a dredge for taking scallops from the waters of Port Phillip Bay; or
- (b) have a scallop dredge on board any boat on the waters of Port Phillip Bay.

(2) The provisions of paragraph (1) (b) do not apply to persons proceeding to waters outside Port Phillip Bay via the most direct route.

Penalty

6. Any person who contravenes this Notice is liable to a penalty of 20 penalty units.
