# Fisheries Act 1968

FISHERIES NOTICE No. 10/95

Fisheries (Scallops—Ocean Fishery) (Close Season) Notice No. 10/1995

I, Charles Geoffrey Coleman, Minister for Natural Resources, after consultation with the Victorian Fishing Industry Federation, make the following Fisheries Notice:

# Title

1. This Notice may be cited as the Fisheries (Scallop—Ocean Fishery) (Close Season) Notice No. 10/1995.

#### Objective

2. The objective of this Notice is to fix a close season on the taking of scallops from Victorian waters other than Port Phillip Bay.

# Commencement

3. This Notice commences on 7 May 1995.

# Authorising Provision

4. This Notice is made under section 80 of the Fisheries Act 1968.

#### Revocation

5. The \*Fisheries (Scallops—Ocean Fishery) Notice No. 7/1995 is revoked.

# Close Season

6. A person must not use a dredge for taking scallops from Victorian waters other than Port Phillip Bay during the period commencing on 7 May 1995 and ending on 28 May 1995.

# Penalty

- 7. Any person who contravenes this Notice is liable to a penalty of 20 penalty units.
