Fisheries (Scallop—Port Phillip Bay Fishery)
(Amendment) Notice No. 16/1995

Title

1. This Notice may be cited as the Fisheries (Scallop—Port Phillip Bay Fishery) (Amendment) Notice No. 16/1995.

Objective

2. The objective of this Notice is to amend the weekly catch rate limit (bag limit) for the taking of scallops from the waters of Port Phillip Bay.

Commencement

3. This Notice commences on 22 August 1995.

Authorising provision

4. This Notice is made under section 80 of the Fisheries Act 1968.

Amendment of catch rate limit

- 5. In the *Fisheries (Scallop—Port Phillip Bay Fishery) Notice No. 15/1995, for clause 8 substitute—
 - "8. A licensee must not take from the waters of Port Phillip Bay or have on board that boat on Port Phillip Bay more than 6 crates of scallops on any one day on which fishing for scallops is permitted under clause 6."
