Local Law No. 2—Amenity and Environment Objective and General Purport

The objectives of this Local Law are:

- * to provide generally for peace order and good government of the municipal district to enable the community and visitors to the municipality to carry out their day to day activities and enjoy their recreational pursuits without having their peace and enjoyment interfered with or destroyed. In doing this, Council will recognise and respond to community expectations relating to quality of life;
- * to control and prevent behaviour which is a nuisance, or which may be detrimental to health and safety or which affects the enjoyment of recreational or other facilities;
- * to control nuisances and noise, odour and smoke emissions and other discharges to the environment which may adversely affect enjoyment of life within the municipal district or health, safety and welfare of persons within the municipal district;
- * to provide and control for the management of traffic, use of roads by persons, vehicles and animals and to regulate the parking of vehicles;
- * to facilitate the provision of general public services held from other community services, property services, recreational and cultural services:
- to provide a safe and healthy environment and protect Council and community assets.

The purpose of each part of the Local Law is as follows:

PART :

To provide for the administration of this Local Law and the setting of fees, charges and costs.

PART 2

To protect Council land.

PART 3

To enable people to enjoy the use of public places and land purchased, leased or otherwise provided, managed or controlled by Council, without nuisance or disturbance from other people and to regulate the use of such land. Specific divisions within this part refer to—

- (1) Municipal buildings.
- (2) Rubbish depot.
- (3) Public reserves and recreation lands.
- (4) Roads, public places and Council land—obstructions and behaviour.
- (5) Consumption of liquor.

PART 4

To regulate street selling, collections, distributions and entertainment.

PART 5

To protect, conserve and control the environment and amenity of the municipal district and to suppress nuisances. Specific divisions within this part refer to—

- (1) Unsightly or dangerous land.
- (2) Open air burning and incinerators.
- (3) Motorised vehicles for recreational purposes.
- (4) Animal welfare.
- (5) Camping caravans and temporary dwellings.
- (6) Nuisance and noise.

PART 6

To-

- (i) promote a physical and social environment free of hazards to health;
- (ii) maintain the municipal district at all times in a clean and sanitary condition;
 and
- (iii) prevent and remedy all nuisances or conditions liable to be dangerous to health or offensive to people.

Specific divisions within this part refer to—

- (1) Garbage collection and recycling.
- (2) Bulk rubbish containers.
- (3) Septic tanks.

PART 7

To provide the method of obtaining permits under other parts of the Local Law.

PART 8

To prescribe the enforcement provisions and penalties in respect to other parts of the Local Law

PART 9

To define the procedure for enforcement and recovery of costs associated with prosecution under the Local Law.

PART 10

To set out Standards to be considered in determining whether to issue a permit in respect to other parts of this Local Law.

 - (a) to control and regulate secondary activities on roads including:
 - (i) trading;

 - (iii) repairs to vehicles; and
 - (iv) parties, festivals and processions; and
 - (v) busking and collections;
 - in a fair, equitable and safe manner which does not compromise the primary need for the passage of people and goods; and
 - (b) to provide unimpeded and safe access for people with sight and movement impairment or disabilities:
- (6) in Part 8-
 - (a) to provide for the safe and efficient management and control of parking on roads in the Municipal District; and
 - (b) to provide mechanisms to manage and control parking so as to cause minimal disruption, danger or nuisance to the users of the Shire's parking facilities;
- to allow and protect the quiet enjoyment by people of Municipal places within the Municipal District;
- (8) to enable people in the Municipal District to carry out their day to day activities and to enjoy their recreational pursuits without having their peace and enjoyment interfered with or destroyed;
- (9) to recognise and respond to community expectations relating to the quality of life they expect and require and are capable of influencing;
- (10) to control and prevent behaviour which is a nuisance, or which may be detrimental to health and safety or which affects the enjoyment of recreational or other facilities;

- (11) to enable the community and visitors and their families who use Municipal places that are available to the public to be confident in their choice of the use of those facilities or places;
- (12) to protect Council and community assets and facilities on or in Municipal places;
- (13) in a way which is consistent with, and in furtherance of, the purposes specified in sub-clauses (7) to (12) of this clause to prohibit, regulate and control—
 - (a) behaviour in Municipal places which is boisterous, offensive, intimidating, dangerous or threatening or which, for other reasons, is inappropriate in a Municipal place; and
 - (b) the places and times at which alcohol may be consumed;
- (14) to provide a safe and healthy environment in which the residents of the Municipal District enjoy a quality of life that meets the general expectations of the community;
- (15) to prohibit, regulate and control activities which may be dangerous or unsafe or detrimental to the quality of life in an environment of the Municipal District:
- (16) to facilitate the provision of general public services, health and other community services, property services, recreational and cultural services and other services in a way which enhances the environment and quality of life in the Municipal District;
- (17) to control nuisances and noise, odour and other discharges to the environment which may adversely affect the enjoyment of life within the Municipal District or the health, safety and welfare of persons within the Municipal District;
- (18) in a way which is consistent with, an in furtherance of, the purposes specified in sub-clauses (15 to (18) of this clause to prohibit, regulate and control activities and circumstances associated with—
 - (a) dangerous and unsightly land;

- (b) storage of machinery, second hand vehicles and second hand goods;
- (c) smoke emissions (particularly from chimneys) and incinerators;
- (d) advertising, bill posting and junk mail:
- (e) camping and temporary dwellings;
- (f) circuses, carnivals and festivals;
- (g) interference with water courses;
- (h) animals and birds, including animal numbers and the keeping and control of animals and birds;
- (i) disposal of waste including behaviour associated with tips;
- (j) drainage tapping; and
- (k) smoking in Municipal properties;
- (19) (a) to provide for the regulation of the collection of used clothing and other goods in recycling bins;
 - (b) to ensure that residents and other persons who wish to make clothing and other goods available for the purposes of charities are able to do so and for that purpose to minimise or eliminate the possibility that such persons might be deceived as to the purposes for which donated clothing and goods are to be put; and
 - (c) to establish a system of control for the location in the municipal district of recycling clothing bins used by certain charities to ensure:

that recycling clothing bins are located on sites which are easily accessible and visible to the public;

that the sites on which the bins are located are kept in a clean condition and that the amenity of the area is not affected by their presence;

that the bins are located in a way that they do not cause an obstruction or a potentially dangerous situation; and

that a nuisance is not caused to owners or occupiers or users of land on which bins are located or land adjacent;

(20) to provide for the administration of the Council's powers and functions; and

(21) to repeal redundant Local Laws.

The general purport of the proposed Local Law includes specification of the form of regulation with a view to achieving the stated objectives. Its aim is to clarify expected standards of conduct within the municipal district to address the welfare of the whole community. In attempting to achieve this aim, it also addresses the environment, streets and roads and community properties, prohibits the doing of acts which would be likely to be detrimental to the general community or to the municipal district and regulates other activities by making them subject to obtaining a permit or exemption from Council and complying with any conditions.

In many instances, it provides for the issue of a Notice to Comply with the local law setting out what needs to be done and within what time. It allows for certain goods and animals to be impounded, provides procedures for recovery of those goods or animals, provides standards guiding the use of some discretions of Shire officers and authorises officers to pursue penalties for non compliance either by infringement notices or by Court prosecution.

Dairy Industry Act 1992 VICTORIAN DAIRY INDUSTRY AUTHORITY Determination

This determination is made by the Victorian Dairy Industry Authority under the powers conferred by section 61 of the Dairy Industry Act 1992 and shall come into operation on 1 October 1995

The determination of milk prices made by the Victorian Dairy Industry Authority and published in the Government Gazette dated 27 July 1995 is revoked.

DETERMINATION

Part 1

Prices Payable for Sales of Standardised Raw Milk

Export sales are sales for the purposes of human consumption as a liquid beyond the territorial limits of the Commonwealth of Australia.

Ultra Heat treated milk (UHT milk) is milk that is processed by subjecting the product to a temperature of not less than 132 degrees centigrade for not less than one second and aseptically packaging it in approved hermetically sealed packages.

Flavoured milk is milk to which flavouring, as defined in the Food Standards Code, has been added so as to alter the odour or taste of the milk to an appreciable extent.

Concentrated skim milk and concentrated whole milk used in the manufacture of market milk is market milk.

Part 2

Prices Payable for Milk supplied to Processors by the Authority

The Authority has determined that all milk will be sold ex factory and that the following prices must be paid for milk sold by the Authority to milk processors.

- (a) Standardised raw milk for processing as daily pasteurised milk for sale in Victoria will be:
 - (i) for flavoured milk and low fat flavoured milk marketed under processor (non VDIA) brands-51.41 cents per litre.

- (k) Standardised raw milk for processing as ultra heat treated milk for sale by export will be 26.11 cents per litre.
- Standardised raw milk for processing as reverse osmosis ultra heat treated milk "Challenge" for sale in Victoria will be 34.31 cents per litre.
- (m) Standardised raw milk for processing as reverse osmosis ultra heat treated milk "Challenge" for sale in Australia, but outside Victoria will be 33.70 cents per litre.
- (n) Standardised raw milk for processing as sterilised milk for sale by export will be 26.11 cents per litre.
- (o) Standardised raw milk for processing as daily pasteurised organic and biodynamic milk for sale in Victoria will be 56.14 cents per litre.
- (p) Standardised raw milk for processing as daily pasteurised organic and biodynamic milk for sale in Australia but outside Victoria will be 53.94 cents per litre.
- (q) Standardised raw milk for processing as concentrated skim milk for use to adjust the solids content in market milk for sale in Victoria will be 35.32 cents per litre.

- (r) Standardised raw milk for processing as concentrated skim milk for use to adjust the solids content in market milk for sale in Australia but outside Victoria will be 34.79 cents per litre.


