BETTING (RAFFLES AND BINGO
PERMITS) (AMENDMENT)
REGULATIONS 1996

I, Roger Hallam, Minister for Gaming, give notice under section 12 of the **Subordinate Legislation Act 1994**, that I have decided that the proposed **Lotteries Gaming and Betting (Raffles and Bingo Permits) (Amendment) Regulations 1996** be made.

A Regulatory Impact Statement was prepared and advertised inviting public comment and submissions. Three submissions were received commenting on the proposed Regulations. All were in favour of the proposed Regulations. Accordingly no amendments have been made to the proposed regulations in the light of these comments.
