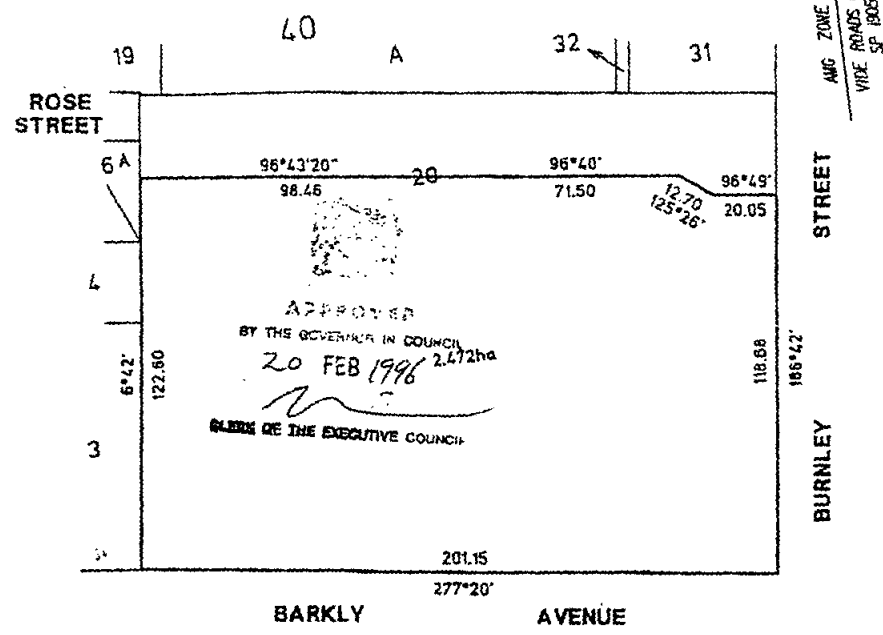
REVOCATION OF PART OF RESERVATION

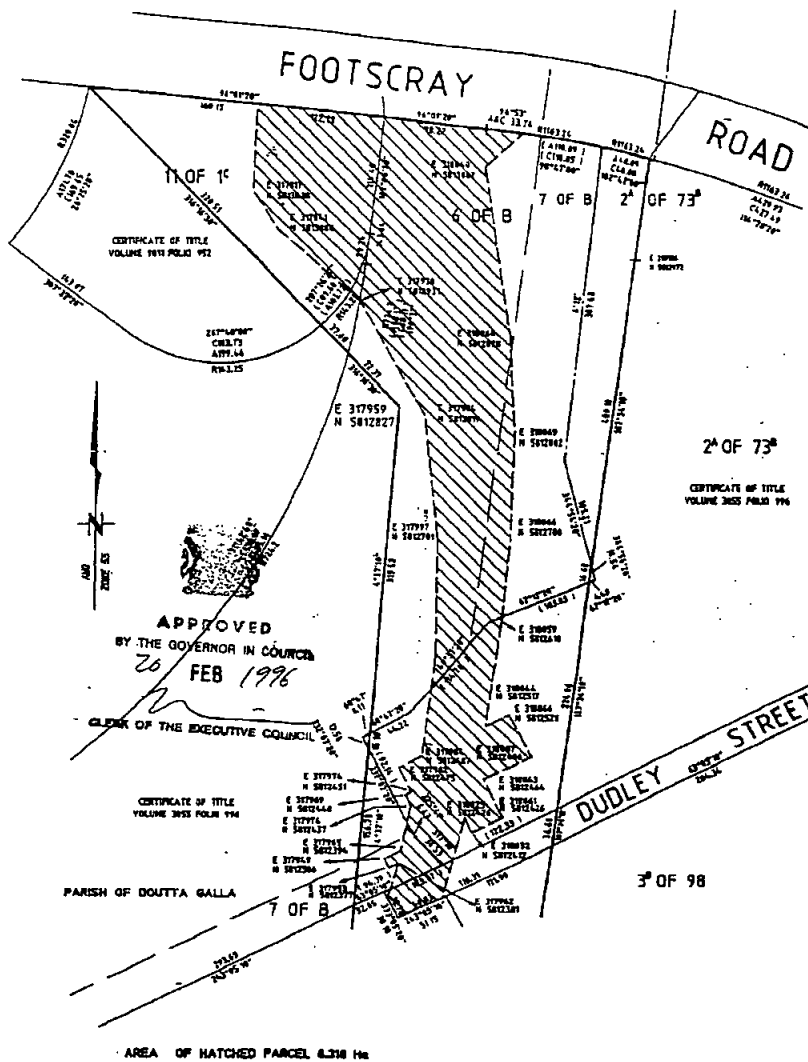

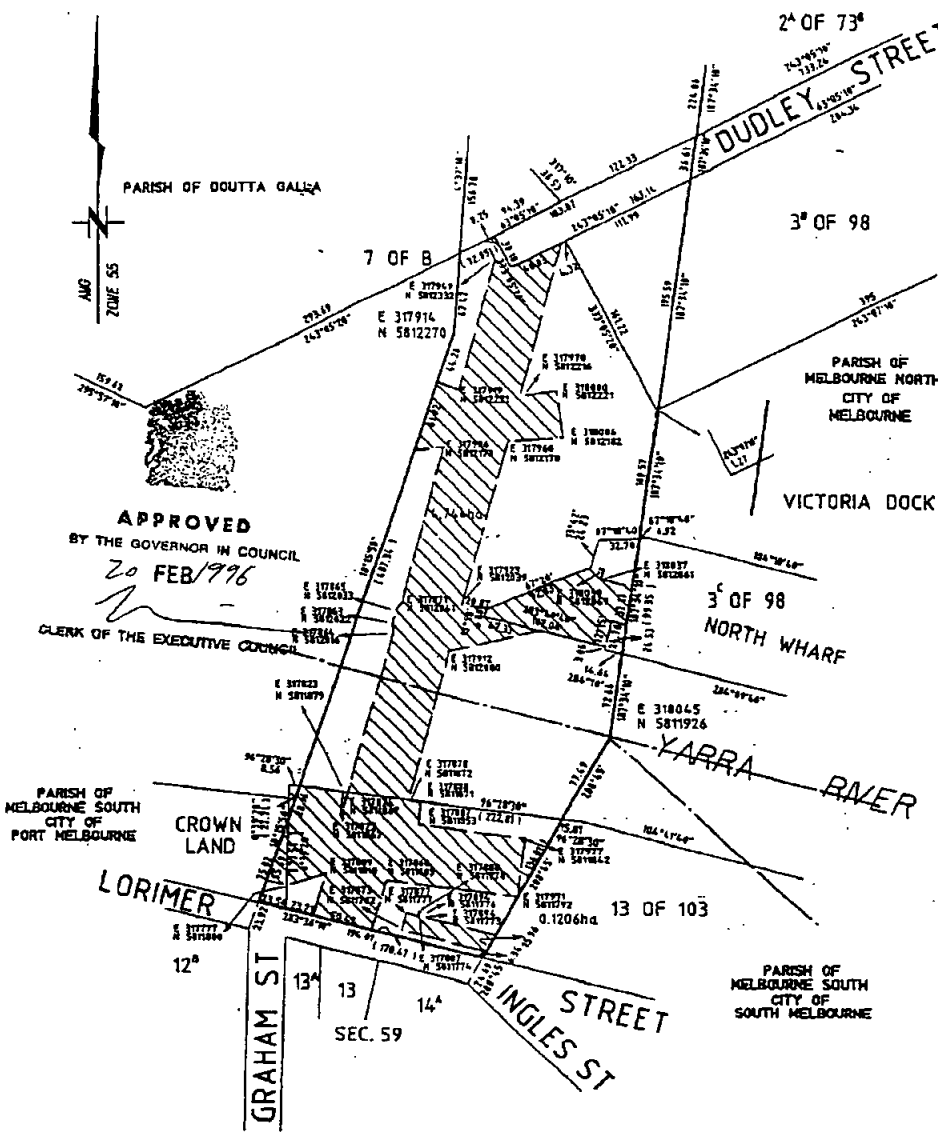

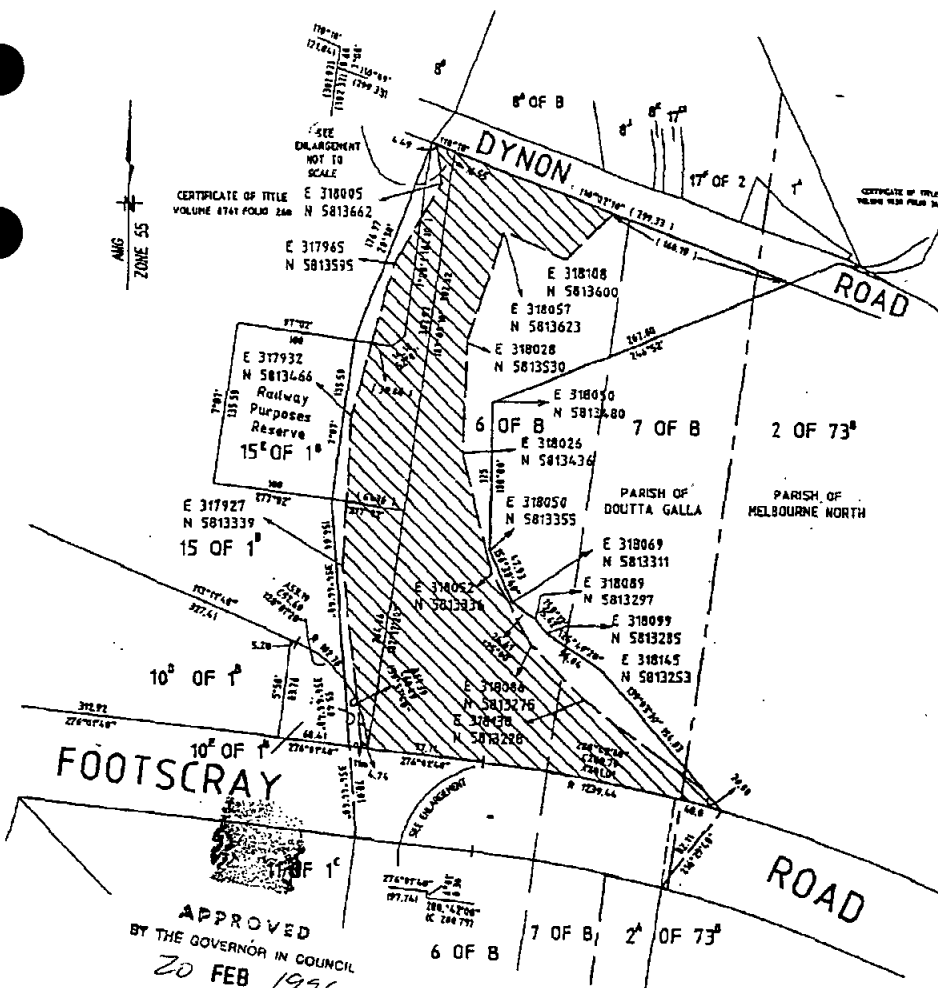
