DECLARATION OF OPERATIONAL STAFF MEMBERS

Pursuant to paragraph (c) of the definition of "operational staff member" under section 3(1) of the Emergency Services Superannuation Act 1986 (the Act) I, the Honourable Roger Murray Hallam in my capacity as Minister for Finance, declare that from 1 January 1997 employees or classes of persons to whom this definition applies for the purposes of the Act to be as follows:
