LOCAL LAW No. 4 Meeting Procedures

Notice is given that the Council of the City of Yarra at its Ordinary Meeting held on 4 March 1996 resolved pursuant to Section 119 of the **Local Government Act 1989** to make the local law known as the Yarra City Council Meeting Procedures Local Law.

The Local Law is made for the purposes of:

- (a) regulating the proceedings for the election of Mayor; and
- (b) regulating the proceedings of Ordinary and special Meetings of Council; and
- (c) regulating the proceedings of meetings of Special Committees composed solely of councillors.

The general purport of the Meeting Procedures Local Law is to facilitate the good conduct of meetings of Council and committees and govern the proceedings for the election of Mayor.

Notice is hereby given that at its meeting on 4 March 1996, Council resolved pursuant to Section 119 on the **Local Government Act 1989** to make Local Law No. 5 Parking Penalties Local Law.

This Local Law is made for the purpose of:

1. creating "parking infringements" (within the meaning of the **Road Safety Act 1986**) for which the Council may by resolution fix a penalty under section 87 of that Act; and
2. to achieve related purposes.

The general purport of the Parking Penalties Local Law is to provide for the efficient and effective enforcement of the Traffic and Parking Acts.

LOCAL LAW No. 6 Common Seal

Notice is given that the Council of the city of Yarra at its Ordinary Meeting held on 4 March 1996 resolved pursuant to Section 119 of the **Local Government Act 1989** to make the local law known as the Yarra City Council Common Seal Local Law (Amendment) Local Law.

The Local Law is made for the purpose of:

- (a) amending Clause 7.1 of the Principle Common Seal Local Law in relation to the authority to affix Council's common seal and acknowledging that a delegate of the Council may authorise the affixing of the common seal; and
- (b) amending Clause 10.1 of the Principle Local Law concerning the necessary signatories required when the common seal is affixed.

The general purport of the Common Seal Local Law (Amendment) Local Law is to amend the principle local law to facilitate the efficient execution of documents for and on behalf of Council.

NOTICE TO PUBLIC BODIES

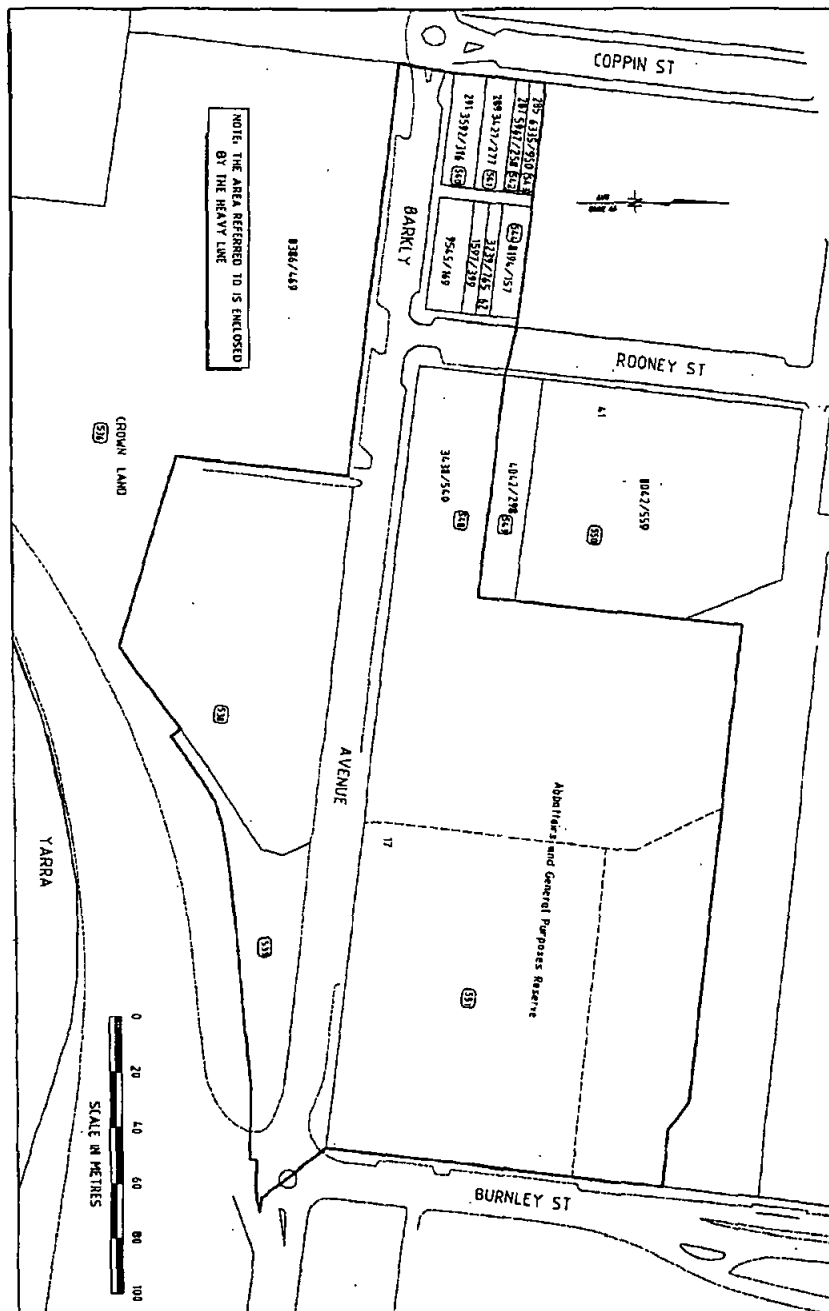
