Crown Land (Reserves) Act 1978
MELBOURNE PARKS AND GARDENS
(JOINT TRUSTEE RESERVES) (THIRD
AMENDMENT) REGULATIONS 1996

Title

1. These Regulations may be cited as the Melbourne Parks and Gardens (Joint Trustee Reserves) (Third Amendment) Regulations 1996.

Principal Regulations

2. The Principal Regulations are the Melbourne Parks and Gardens (Joint Trustee Reserves) Regulations 1994, made on 25 October 1994, and published in the Government Gazette on 12 January 1995, pages 94-102, for and with respect to each of the Crown Lands in the City of Melbourne known as Alexandra Park, Fawkner Park, Flemington and Kensington Park, Flinders Park, Princes Park, Yarra Park, Carlton Gardens, Fitzroy Gardens, Flagstaff Gardens, Powlett Reserve, North Melbourne Recreation Reserve, Argyle Square, Curtain Square, Darling Square, Lincoln Square, Macarthur Square, Murchison Square and University Square.

Authorising Provisions

3. These Regulations are made under Section 13 of the Crown Land (Reserves) Act 1978.

Commencement

4. These Regulations come into effect on the date they are published in the Victoria Government Gazette.

Amendment regulation 19

5. For regulations 19 (1) and 19 (2) of the Principal Regulations, substitute—

19 (1) The Committee may, once in each 12 month period, approve that part of Carlton Gardens delineated and shown hatched on the plan in Schedule 2, to be enclosed and used for a period not exceeding 14 days for the holding of a specially mounted horticultural exhibition of flowers, plants, shrubs and trees in those Gardens.



- (2) While an exhibition as provided for in sub-regulation (1) is being held in the Carlton Gardens and is open to the public—
 - (a) the Committee; or
 - (b) the persons or organisation responsible for mounting and holding the exhibition, with the consent of the Committee—

may determine, make and collect a daily charge not exceeding \$15.00 per person for entry to the exhibition.

(3) For the plan and heading in Schedule 2 of the Principal Regulations substitute—

Dangerous Goods Act 1985
NOTICE OF CHANGE TO REFERENCES TO
"DANGEROUS GOODS" AND
ASSOCIATED TERMS IN VARIOUS
REGULATIONS

Under section 16 (3) of the Subordinate Legislation Act 1994 notice is given of the operation and making of amendments to various regulations under the Dangerous Goods Act 1985. The regulations affected are the Dangerous Goods (Liquefied Gases Transfer) Regulations 1987, the Dangerous Goods (Storage and Handling) Regulations 1987 and the Dangerous Goods (Transport) Regulations 1987. The regulation that gives effect to the changes is called the Dangerous Goods (Amendment) Regulations 1996 and it come into operation on 16 April 1996.

The amendments to the above regulations alter references to dangerous goods and associated terms such as "class" and "subsidiary risk" to be consistent with the amendment to the **Dangerous Goods Act 1985** which came into effect on 15 April 1995. On that date, various provisions of the **Dangerous Goods (Amendment) Act 1995** came into operation to amend the **Dangerous Goods Act 1985**. The primary effect of the amendment to the Act was to insert a definition of dangerous goods in the Act. Previously dangerous goods were defined by the Dangerous Goods (Prescribed List) Regulations 1986—these regulations expire on 17 April 1996.
