## **Melbourne City Link Act 1995** **NOTICE TO PUBLIC BODIES**

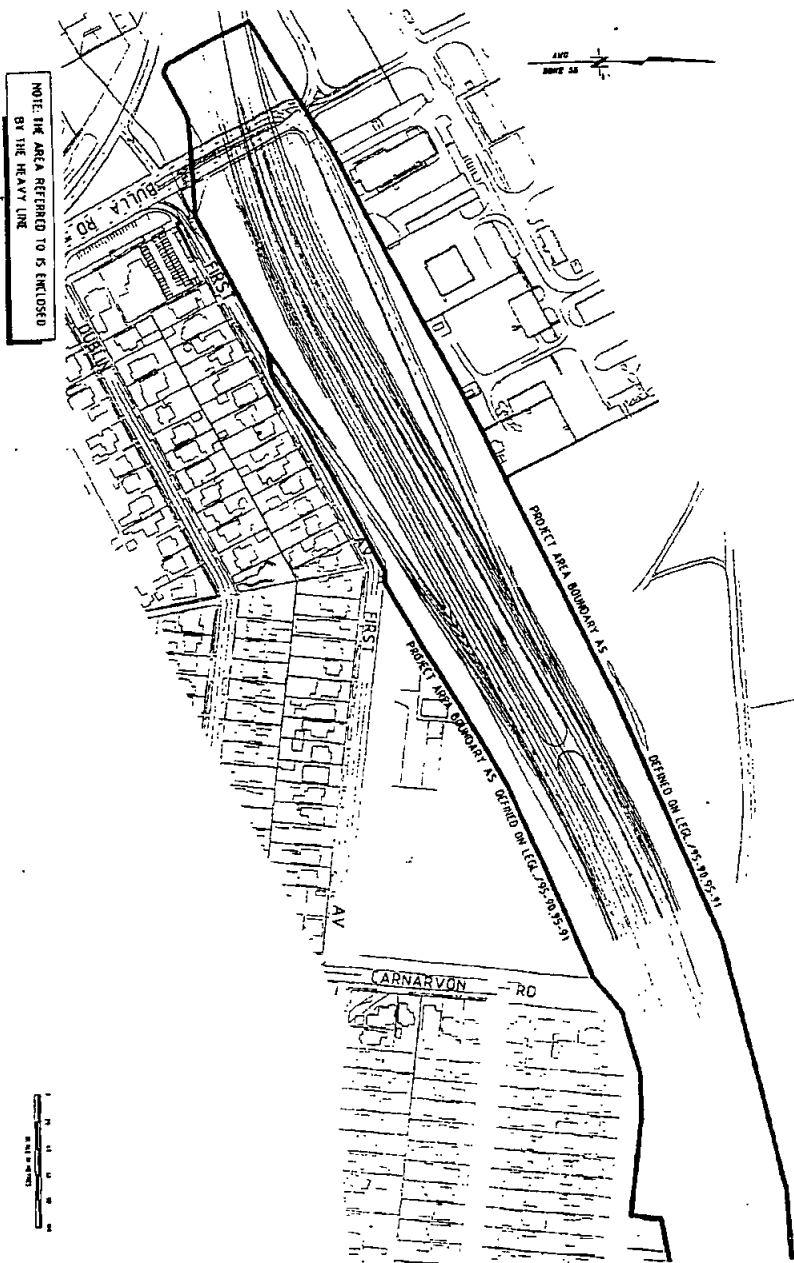
