### SCHEDULE OF THE AREAS DECLARED AS A "NEW AREA" PURSUANT TO \$39B OF THE GAS INDUSTRY ACT 1994

The "New Area" is located in the Central Murray Region and is defined by the following boundaries:

## Victoria:

An Eastern Boundary that is three km east of the Beechworth/Howlong Road.

A Western Boundary being the Shepparton/Barmah Road.

Between the Eastern Boundary and the Western Boundary, a 15 km radius around each of the towns of Chiltern, Rutherglen, Wahgunyah, Yarrawonga, Cobram, Yarroweyah, Strathmerton, Numurkah and Nathalia or 15 km South of the Murray Valley Highway whichever is the greater.

#### New South Wales:

A Northern Boundary that includes the Shires of Berrigan, Conargo, Corowa, Deniliquin, Jerilderie (being Local Government areas under the New South Wales Local Government Act 1993 as at 1 July 1994) and a 15 km radius around the towns of Howlong in the Shire of Hume and Mathoura in the Shire of Murray.

## Melbourne City Link Act 1995 NOTICE TO PUBLIC BODIES




