MOONEE VALLEY PLANNING SCHEME Notice of Approval of Amendment

Amendment L3

The Minister for Planning and Local Government has approved Amendment L3 to the Moonee Valley Planning Scheme.

The amendment comes into operation on the date this notice is published in the Government Gazette.

The amendment rezones land formerly known as Niddrie Technical School, Rose Avenue, Niddrie, from a Technical School and a Melbourne Metropolitan Board of Works reservation to a Residential C zone and Public Open Space reserve.

The amendment also applies a road closure overlay to land within the Technical School reservation which appears as a road on the land title.
