COUNTY COURT (BAILIFF'S FEES) ORDER

A Regulatory Impact Statement has been prepared in relation to the proposed County Court (Bailiff's Fees) Order 1996.

The major objective of the proposed Order is to ensure that litigants using the services of the County Court Bailiff to enforce civil judgements make an equitable contribution to the costs of provision of the service.

The existing Order which establishes Bailiff's fees in the County Court is due to sunset shortly. The impact statement examines the level at which fees for identifiable services should be fixed.

The regulations do not propose an increase to the amount of the fee payable for warrants other than warrants of possession or combined warrants. The regulations establish fees that are identical with those for executing similar types of warrants from other Court jurisdictions, thus providing a level of consistency that reduces costs of administration and compliance.

MELBOURNE CITY COUNCIL Conduct of Meetings Local Law 1996 (No. 1 of 1996)

Notice is hereby given that at the ordinary meeting of the Melbourne City Council held on 30 January 1996 the Council resolved to commence the process for the making of its Conduct of Meetings Local Law 1996 (No. 1 of 1996).

The purpose of the proposed Local Law is to:

- (a) regulate proceedings for the election of the Lord Mayor;
- (b) regulate proceedings at all Ordinary and Special Meetings of Council and meetings of Special Committees;
- (c) regulate the use of the common seal and prohibit its unauthorised use;
- (d) repeal Local Law No. 10 of 1990 (Meeting Procedures (Standing Orders) Local Law 1990); and
- (e) repeal Local Law No. 9 of 1990 (Common Seal Local Law 1990).

The general purport of the proposed local law is to provide good government through the application of the provisions of the Local Law as follows:

- (a) procedures for the election of the Lord Mayor;
- (b) procedures for the regulation of all Ordinary and Special Meetings of Council and meetings of Special Committees;
- (c) procedures to regulate the use of the common seal and prohibit its unauthorised use;
- (d) creates offences for disorderly and improper conduct; and
- (e) through the application of a Meeting Procedures Code, provides comprehensive guidelines for the conduct of meetings of Council and special committees.
