NOTICE OF DECISION

Proposed Zoological Parks and Gardens
(Administration) (Charges) Regulations 1996

I, Marie Tehan, Minister for Conservation and Land Management, and Minister responsible for administering the Zoological Parks and Gardens Act 1995 give notice under section 12 of the Subordinate Legislation Act 1994, as follows—

A regulatory impact statement (RIS) was prepared in relation to the proposed Zoological Parks and Gardens (Administration) (Charges) Regulations 1996 and advertised inviting public comment and submissions. No submissions were received. Accordingly I have decided that the proposed Regulations be made without amendment.

2. Objective

The objective of this Notice is to prohibit absolutely the taking, destroying or hunting of Sambar Deer by the use of scent-trailing hounds or gun dogs in an additional part of Victoria during the period commencing 23 June 1996.

3. Authorising Provision

This Notice is made under section 86 (1) of the **Wildlife Act 1975**.

4. Hunting of Sambar Deer by the use of Scent-trailing Hounds or Gun dogs

The use of scent-trailing hounds or gun dogs for the purposes of taking, destroying or hunting of Sambar Deer is prohibited absolutely in the area described in the Schedule below during the period commencing 23 June 1996.

5. Penalty

Any person who contravenes this Notice is guilty of an offence and liable to a penalty not exceeding 25 penalty units.

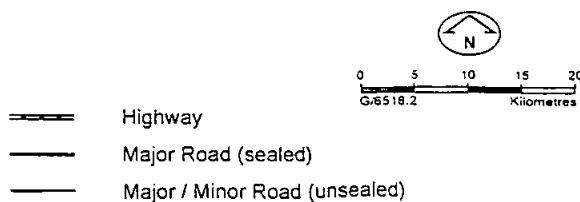
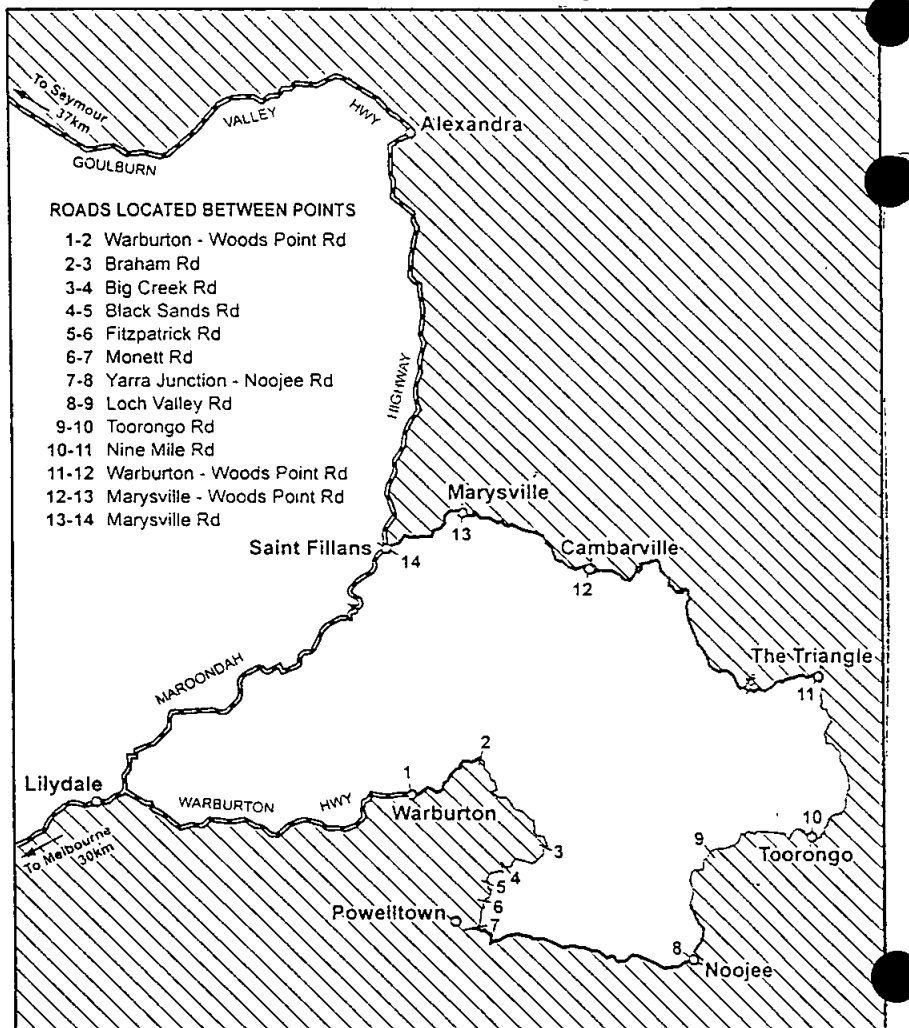
WILDLIFE (CLOSURE OF AREA TO HUNTING WITH HOUNDS) NOTICE No. 2/1996

1. Title

This Notice may be cited as the Wildlife
(Closure of Area to Hunting with Hounds)
Notice No. 2/1996.

SCHEDULE

The area referred to in Clause 4 is that part of Victoria which is east of the Hume Highway and indicated on the following plan not marked by hatching.



Note: Subject to this Notice and any other relevant legislation, the use of dogs for the purpose of hunting deer is prohibited in Victoria under the **Wildlife (Game) Regulations 1990**, other than in the area of Victoria bounded on the south by the Princes Highway and on the west by the Hume Highway.
