### Melbourne City Link Act 1995

#### REVOCATION OF PART OF RESERVATION

The Governor in Council, on the recommendation of the Minister for Planning and Local Government (being the Minister administering the Melbourne City Link Act 1995), under section 29(2) of the Melbourne City Link Act 1995 revokes:

#### North Melbourne

- (a) the Order in Council of 25 February 1895 (vide Government Gazette 1 March 1895, p.879) permanently reserving land at North Melbourne as a Site for Railway purposes;
- (b) the Crown Grant Volume 2577 Folio 360—

in so far as the Order and the Crown Grant related to the land shown hatched on plan numbered LEGL./96-99 lodged in the Central Plan Office.

#### Hawstead

The Order in Council of 8 September 1964 (vide Government Gazette 16 September 1964, p.2914) permanently reserving land at Hawstead as a Site for Public Park and Playground in so far as the Order relates to the land shown hatched on plan numbered LEGL./96-210 lodged in the Central Plan Office. (Rs.2310.)

#### Brunswick

The Order in Council of 6 April 1903 (vide Government Gazette 15 April 1903, p.1194-5), temporarily reserving land at Brunswick (Moonee Vale) as a Site for Public purposes in so far as the Order relates to the land shown hatched on plan numbered LEGL./96-211 lodged in the Central Plan Office.

#### Brunswick

The Order in Council of 19 November 1918 (vide the Government Gazette 27 November 1918, p.3381-2) temporarily reserving lands at Brunswick as Sites for Public purposes in so far as the Order relates to the lands shown hatched on plans numbered LEGL/96-212 and LEGL/96-213 lodged in the Central Plan Office.
