Melbourne City Link Act 1995 DIVESTING OF LAND

The Governor in Council, on the recommendation of the Minister for Planning and Local Government (being the Minister administering the **Melbourne City Link Act 1995**) and the Minister for Transport (being the Minister administering the relevant provisions of the Act under which the Public Transport Corporation is established), under section 31(1) of the **Melbourne City Link Act 1995** divests from the Public Transport Corporation the land specified in the Schedule.
