**SCIENTIFIC ADVISORY COMMITTEE**

The **Flora and Fauna Guarantee Act 1988** enables members of the public to nominate threatened species, communities and potentially threatening processes for listing under the Act. Nominations under the Act are considered by a Scientific Advisory Committee which makes recommendations to the Minister.

The Scientific Advisory Committee has made a preliminary recommendation on the evidence available, in accordance with Section 14 of the Act, that the nomination for listing of *Larus pacificus pacificus*—Pacific Gull (eastern subspecies) not be supported in accordance with Section 11 of the **Flora and Fauna Guarantee Act 1988**.

The reason that the nomination is not supported is that the item does not satisfy at least one primary criterion of the set of criteria maintained under Section 11 of the Act.

Submissions supplying evidence that confirm or contradict this preliminary recommendation will be accepted until 29 April 1996. Please note that only nature conservation issues are considered by the Scientific Advisory Committee.

A Recommendation Report has been prepared for the recommendation. **Subordinate Legislation Act 1994**  
**REGULATORY IMPACT STATEMENT**  
**Road Safety (Procedures) (Sign Penalties)**  
**Regulations 1996**

Notice is given in accordance with section 11 of the **Subordinate Legislation Act 1994** that a Regulatory Impact Statement (RIS) has been prepared in relation to the Road Safety (Procedures) (Sign Penalties) Regulations 1996.

The Parliamentary Road Safety Committee recommended that penalties for disobeying traffic signs should be reviewed, and amended to ensure that the Infringement Notice penalty for disobeying signs that in general have little or no safety impact is less severe than the Infringement Notice penalty for disobeying signs that are primarily safety related. At present the Infringement Notice fine for disobeying a sign at an intersection is \$165, and the Infringement Notice penalty for disobeying a sign not at an intersection is \$105. All "disobey sign" offences attract three demerit points.

An assessment has been made of the circumstances in which each kind of sign is used, and the purpose it is intended to achieve. Signs have been classified into two groups; a group primarily for safety related purposes, and a group used primarily for purposes other than safety. It is proposed that disobeying signs in the first group attract an Infringement Notice fine of \$165 and three demerit points, and disobeying signs in the second category have an Infringement Notice fine of \$105, and not attract demerit points.

The following signs were determined to warrant the more severe penalty: STOP, GIVE WAY, STOP HERE ON RED SIGNAL, STOP HERE ON RED ARROW, NO OVERTAKING OR PASSING, NO OVERTAKING ON BRIDGE, EMERGENCY STOPPING LAND ONLY, ONE WAY, DO NOT ENTER, NO ENTRY, ROUNDABOUT.

The following signs were determined to warrant the less severe penalty: LOW CLEARANCE, NO TRUCKS, ALL TRUCKS MUST ENTER, ALL BUSES MUST ENTER, all signs prohibiting or requiring turning, KEEP LEFT, KEEP RIGHT, NO EXIT.

Additionally, the Infringement Notice penalty for disobeying a bridge load limit sign will be increased to a scale that results in higher fines for higher mass over the limit. The penalties proposed are similar to those for disobeying mass limits applicable to roads other than bridges.

**VICTORIAN STRAWBERRY INDUSTRY**  
**DEVELOPMENT ORDER**

*Citation*

1. This industry development order may be cited as the Victorian Strawberry Industry Development Order 1996.

*Order made under the Agricultural Industry*  
*Development Act 1990*

2. This Order is made under Part 2 of the **Agricultural Industry Development Act 1990**.

*Purposes of Order*

3. The purposes of this Order are to set up a Committee to—

- (a) carry out or fund domestic marketing and promotion of fresh strawberries grown in the State of Victoria, and
- (b) carry out or fund research and development into the production, pest and disease control, post harvest handling, plant breeding and variety evaluation of strawberries and advise growers about research findings.

*Definitions*

4. In this Order:

“Act” means the **Agricultural Industry Development Act 1990**.

“Committee” means the Victorian Strawberry Industry Development Committee.

“Grower” means:

- (a) a person by whom, or on whose behalf, strawberries are commercially grown or produced in the State of Victoria, or a person who purchases strawberry runners for resale to commercial strawberry growers in the state of Victoria; and
- (b) where strawberries are commercially grown or produced in the state of Victoria by a partnership or under a share farming agreement, the partnership or the parties to that agreement—but does not include a person engaged as an employee on wages, a salary or piece work rates.

“Minister” means the Minister administering the Act.

“Production area” means the State of Victoria.

“Runners” means, strawberry rootlings that are produced by strawberry runner growers for sale to strawberry growers.

“Strawberries” means any variety of strawberry grown or produced for sale for fresh consumption or processing.

“Strawberry runner growers” means all strawberry runner growers producing and supplying strawberry runners used by Victorian strawberry growers for the purpose of producing fresh, frozen, and processed strawberries.

*Term of Order*

5. This Order commences on the day of the date of its publication in the Government Gazette and remains in force for four years from that date.

*Establishment of Committee*

6. There will be a “Victorian Strawberry Industry Development Committee”.

*Members*

7. The Committee must consist of seven members appointed by the Minister being—

- (a) four voting grower members nominated by the Victorian Strawberry Growers' Association or any other relevant body that, in the opinion of the Minister, has replaced that body; and

- (b) two voting non-grower members nominated by the Victorian Strawberry Growers' Association or any other relevant body that, in the opinion of the Minister, has replaced that body who possess specialist expertise appropriate to the needs of the strawberry industry in the fields of promotion, marketing, industry development or business administration; and
- (c) one non-voting member nominated by the Secretary of the Department of Agriculture, Energy and Minerals who possess appropriate scientific experience in research and development.

*Chairperson*

8. The voting members of the Committee must elect a voting member of the Committee to be Chairperson of the Committee for a period of 12 months.

*Functions of Committee*

9. The Committee must—

- (a) carry out or fund domestic marketing and promotion of strawberries grown in the state of Victoria; and
- (b) carry out or fund research and development into the production, pest and disease control, post harvest handling, plant breeding and variety evaluation of strawberries and advise growers about research findings.

*Powers of Committee*

10. The Committee may—

- (a) impose a charge on all growers for services it provides;
- (b) act as an agent for any person in relation to the purchase of equipment, machinery, planting material, fertiliser or any other thing used in the production of strawberries;
- (c) delegate any of its powers, duties or functions (other than the power of delegation) to an employee of the Committee;
- (d) exempt by written notice, either conditionally or unconditionally, a person or class of persons from compliance with some or all of the requirements of this Order.

*Charge Imposed by Committee*

- 11. (a) A charge imposed by the Committee must be at a uniform rate and be based on the purchase of strawberry runners by strawberry growers or their agents.
- (b) A charge is payable by strawberry growers at the point and time of sale of strawberry runners, and is to be collected by strawberry runner growers or their agents by arrangement with and on behalf of the Committee.
- (c) The first charge imposed by the Committee must be at the rate of \$12 per 1000 strawberry runners which will remain in force until the end of the financial year during which it was imposed.
- (d) A charge imposed by the Committee must not at any time during the term of the Order exceed the rate of \$14 per 1 000 runners.
- (e) A charge must be reviewed by the Committee at the end of each financial year and must not be varied unless the variation has been approved by a majority of growers at the Annual Meeting of the Committee.

*Distribution of Proceeds of Charge*

- 12. (a) The Committee must apply the proceeds of a charge imposed on growers towards—
  - (i) domestic promotion and marketing of strawberries grown in the State of Victoria; and
  - (ii) carrying out or funding research and development into the production, pest and disease control, post harvest handling, plant breeding and variety evaluation of strawberries and advise growers about research findings; and
  - (iii) meeting other costs necessarily incurred in providing the Committee's services to growers.
- (b) The Committee must apply the proceeds of a charge in accordance with any funding priorities set out in the Plan of Operation of the Committee.



*Meetings*

13. (a) The Committee must hold an Annual Meeting in each financial year at which time any variation to a charge must be considered and voted on by growers.
- (b) At the Annual Meeting the Chairperson of the Committee must report to growers on the operation and finances of the Committee during the previous 12 months.
- (c) The timing of all meetings of the Committee, including the Annual Meeting, is at the discretion of the Committee.

*Financial Year*

14. The financial year of the Committee is the period from 1 July to 30 June.

*Plan of Operation*

15. (a) The Committee must within the first 12 months of its operation produce a Plan of Operation which is to be submitted to the Minister and which is to include the aims and objectives of the Committee's promotion and research activities during the term of the Order.
- (b) In determining the aims and objectives to be included in a Plan of Operation, the Committee must have regard to any priority guidelines for promotion and research and development which have been adopted by the Victorian Strawberry Growers' Association.
- (c) The Plan of Operation must be published by the Committee and made available to all growers.

*Voting*

16. (a) For the purpose of voting at a future poll on the question of the continuation of the Order, a grower producing strawberries in the immediate preceding year is eligible to vote.
- (b) Eligibility to vote is to be on the following basis:
  - (i) Individual producer—1 vote;
  - (ii) Company—1 vote;
  - (iii) Partnership—1 vote for each partner;
  - (iv) Share farming agreement—1 vote for each party to the agreement.

*Penalty for Contravening the Order*

17. A grower who fails to comply with the requirements of Clause 11 relating to the payment of a charge imposed by the Committee contravenes this Order and is liable to a penalty not exceeding 20 penalty units. One penalty unit is currently \$100.

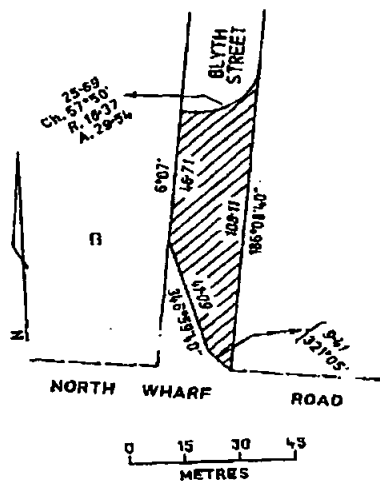
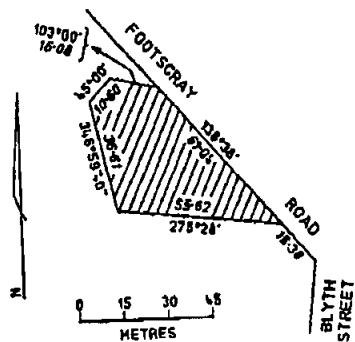

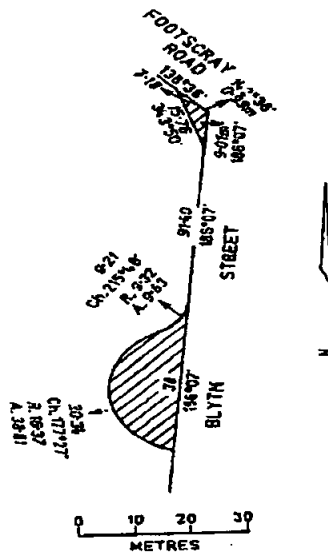
