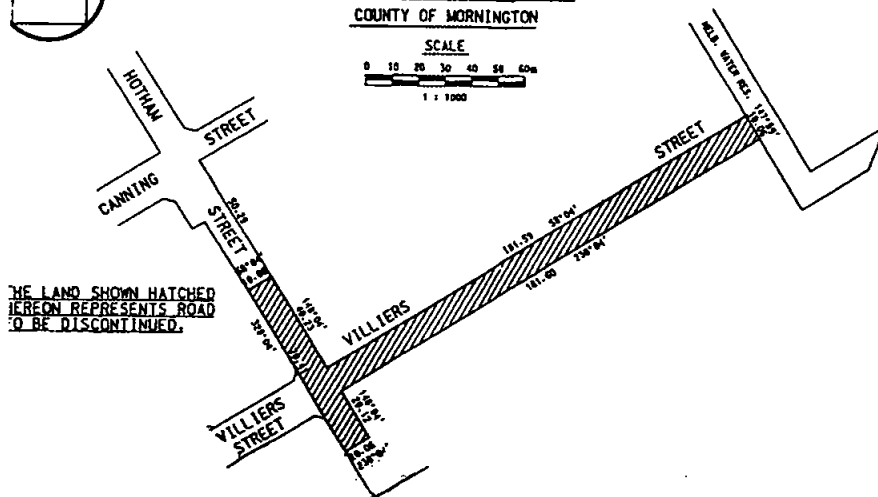

Notice is given in accordance with Section 11 of the **Subordinate Legislation Act 1994** that a Regulatory Impact Statement (RIS) has been prepared in relation to the Road Safety (Vehicles) (Hazardous Areas) Regulations 1996.

Previously, hazardous areas (snowfields) requirements under the Transport (Passenger Vehicles) Regulations 1994 applied only to passenger vehicles with more than 12 seats which were licensed under the Transport Act. Typical vehicles which were not controlled by these Regulations included interstate buses, government/defence force buses, hire/drive buses and courtesy buses. These un-licensed vehicles were not required to comply with the vehicle safety standards, carriage of safety items and special snow driving skills required under the Regulations.

The objective of the proposed regulatory change is to include all licensed vehicles (as previously) and non-licensed buses of over 30 seats. It is considered that these larger buses should be subject to the requirements of the Regulations as any accident involving them had potential for great loss of life or injuries.

The proposed regulations:

- Continue the previous requirements for the operation of licensed buses in hazardous areas.
- Include the requirement for all buses of over 30 seats to comply with the regulations regardless of whether they are required to be licensed under Victorian regulations.
- Delete the requirement for a bus to undergo a Hazardous Area Inspection by a Licensed Bus Tester.

Catchment and Land Protection Regulations  
1996

Notice is given under Section 11 of the **Subordinate Legislation Act 1994** that a Regulatory Impact Statement has been prepared in relation to the proposed Catchment and Land Protection Regulations 1996.

The objectives to be achieved by the proposed Regulations are to:

- (a) prevent the poisoning of species that poison baits are not intended to eradicate or control;
- (b) prevent the misuse of poison baits;
- (c) ensure that interested parties can obtain information regarding land use conditions or land management notices applicable to a particular area.

The economic impact of pest animals such as rabbits, wild dogs and foxes on agricultural industries due to loss of production is estimated to be well over \$120 million per annum.

The Regulations are required to assist the Department of Natural Resources and Environment to discharge its statutory functions to control the provision, transportation, use and retrieval of poison baits by prescribing techniques which minimise the risk to human safety, wildlife and other non-target species.

The Regulations prescribe a time limit for storing poison baits, baiting techniques for different pest animals and provisions to minimise damage to non-target animals and wildlife.

The Regulations also ensure that organisations with responsibility for land management are able to access information about the provisions of land use conditions and land management notices that may apply to any particular land which will assist in promoting co-operative planning between organisations and the achievement of community objectives.

The RIS examined the impact of the new Regulations in two parts; the provisions relating to poison baits and those concerning land management notices. The alternatives to each of these elements of the proposed Regulations that were examined in the RIS are outlined below:

#### Poison Baits

The alternative to the proposed Regulations is to allow landholders to hold stocks of 1080 and Pindone rather than the Department of Natural Resources and Environment. Landholders would be subject to licensing requirements of the Department of Human Services and would need to provide secure storage facilities. Allowing landholders to hold stocks of 1080 and Pindone was rejected because the Department of Natural Resources and Environment could not monitor or be responsible for compliance with poison bait standards. Deviation from these standards would result in an increased risk to human health and safety and non-target animals, including wildlife.

#### Land Management Notices

Unrestricted access of the Register of land use conditions and land management notices is the only alternative to the proposed Regulations.

A general right of access was rejected because of the potential that the information provided in response to some inquiries could be used in a mischievous manner by allowing individuals to be targeted by businesses promoting a product or technique to treat land degradation problems. It would also place a greater demand on the Department of Natural Resources and Environment staff to view the Register which would lead to higher administrative costs.

The RIS concluded that the proposed Regulations are the most effective means of meeting the stated objectives.

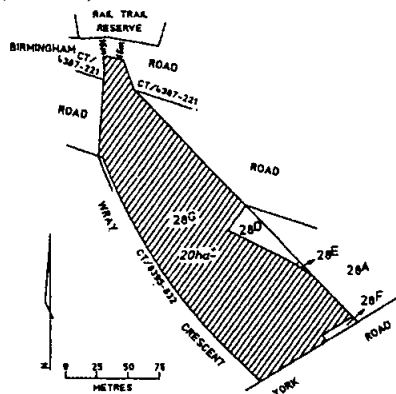
