EXEMPTION Application No. 28 of 1996

The Anti-Discrimination Tribunal constituted by the President pursuant to Section 83 (5) (a) (ii) of the Equal Opportunity Act 1995 ("the Act") has considered an application pursuant to Section 83 of the Act by, Young Women's Housing Collective Incorporated in respect of a program known as Young Women's Housing Shopfront.

Upon reading the material tendered in support of this application the Tribunal is satisfied that it is appropriate to grant an exemption from Sections 13, 100 and 195 of the Act to permit the applicant to advertise for and employ as occasion requires female only workers in respect of the Young Women's Housing Shopfront program.

In granting this exemption the Tribunal noted:

- * the role of workers at the Shopfront is to provide support, counselling and advocacy in a women's only environment for young women who are homeless or at risk of homelessness;
- the collective manages 12 houses and workers are employed to provide support to tenants;
- several of these houses specifically accommodate Muslim young women and others are targeted at lesbian young women;
- over 80% of the Shoptfront's clients are fleeing experiences of incest, rape, domestic violence and other forms of abuse;
- the Shopfront's clients wish to work through issues associated with their experiences of abuse with female workers.

The Tribunal grants an exemption from the operation of Sections 13, 100 and 195 of the Equal Opportunity Act 1995, this exemption to remain in force until 17 July 1999.

NURSES BOARD OF VICTORIA

On 17 June 1996, a panel appointed by the Nurses Board of Victoria, found that Adam Kyall Elbourne of 818 Tress Street, Mount Pleasant 3350 identification number 146055, registered in division 1, had engaged in unprofessional conduct of a serious nature.

The panel determined that:

- 1. The suspension of the nurse's registration ordered by the Board on 22 May 1996, which commenced on 6 June 1996, be extended until removed in accordance with this determination.
- 2. After 6 November 1996, subject to Paragraphs 3-6 of this determination, the suspension of the nurse's registration may be removed, on application to the Board, but only if the following conditions and restrictions imposed pursuant to Paragraph 48 (2) (e) of the Act have been and are observed.
 - (a) From 12 July 1996 until the suspension is removed, the nurse may not work, in any capacity for:
 - (i) a registered funded agency; nor
 - (ii) a health service establishment,
 - as those terms are defined in Section 3 Health Services Act 1988 of Victoria, nor as or for a nurse's agent, as defined in Section 3 Nurses Act 1993.
 - (b) The nurse must consult as soon as possible a psychiatrist or drug counsellor (a "counsellor") satisfactory to the Board and continue to consult with that Counsellor at least once a month, or more often if the counsellor recommends, leading to a written report from the counsellor that is satisfactory to the Board being provided to the Board with the application to remove the suspension.
 - (c) The nurse attend a medical practitioner acceptable to the Board on at least 5 occasions during his suspension on random dates nominated at short notice by the practitioner, and undergo drug

- screenings on which the practitioner must provide reports to the Board before the suspension is removed and which reports must be satisfactory to the Board.
- 3. Until at least 12 months after the suspension of the nurse's registration is removed pursuant to Paragraph 2 of this determination, his registration shall be subject to the following conditions, restrictions and limitations ("conditions").
 - (a) He must continue to consult with a counsellor (as defined in Paragraph 1) at such intervals as the counsellor may recommend during the whole of the 12 months.
- (b) The nurse must undergo at least 13 random drug screenings during the 12 month period in accordance with the regime established in Sub-paragraph 2 (c) of this determination.
- (c) The nurse may not, without supervision by a nurse registered in division 1 or a registered medical practitioner, have access to, nor administer, drugs referred to in Schedules 4 or 8 of the Drugs Poisons and Controlled Substances Act 1981.
- 4. The conditions imposed on the nurse's registration by Paragraph 3 of these orders may be removed, on application to the Board, which application must be accompanied by:
 - (a) a written report by the counsellor referred to in Sub-paragraph 3 (a) of this determination that is satisfactory to the Board;
 - (b) reports of the drug screenings pursuant to Sub-paragraph 3 (b) which are satisfactory to the Board; and
 - (c) a written report on his nursing performance by each of his then current employers, which is satisfactory to the Board.
- 5. Until at least 12 months after the conditions imposed on the nurse's registration by Paragraph 3 of this determination are removed pursuant to Paragraph 4, his registration shall be subject to the following further conditions and restrictions.
 - (a) He must continue to consult with a counsellor, (as defined in Paragraph 1), at such intervals as the counsellor may recommend during the whole of the 12 months.

- (b) The nurse must undergo at least 13 random drug screenings during the 12 month period in accordance with the regime established in Sub-paragraph 2 (c) of this determination.
- 6. The conditions imposed on the nurse's registration by Paragraph 5 of this determination may be removed, on application to the Board, which application must be accompanied by:
 - (a) a written report by the counsellor referred to in Sub-paragraph 5 (a) of this determination that is satisfactory to the Board;
 - (b) reports of the drug screenings pursuant to Sub-paragraph 5 (b) which are satisfactory to the Board; and
 - (c) a written report on his nursing performance by each of his then current employers, which is satisfactory to the Board.






