





"entitlement date" means the date fixed by Order in Council for the purposes of Division 1 of Part 3 or the date determined under Section 24 (7).

The Electoral Commissioner must on or before a date to be specified by Order in Council in each year (being a date after the entitlement date) supply to the Chief Executive Officer a voters' list for each ward of the persons who appear to the Electoral Commissioner to be entitled to be enrolled on the voters' roll under Section 11 (1).

The Chief Executive Officer must on or before a date to be specified by Order in Council in each year (being a date after the entitlement date) make out a voters' list of the persons who appear to the Chief Executive Officer to be entitled to be enrolled on the voters' roll or rolls under Section 11 (2), 11 (4), 12, 13 (1) or 13 (3).

In the case of a Council which holds triennial elections, the Chief Executive Officer must not later than 3 days before nomination day in any year in which a triennial election is to be held and not later than a date to be specified by Order in Council in any other year certify in writing that the voters' roll has been prepared in accordance with this Act.
