

- to provide a mechanism for addressing alleviation of fees where enforcement of payment would otherwise impose unreasonable hardship;
- to provide for the peace, order and good government of the municipal district; and

 to provide for the administration of the Council's powers and functions.

### BRIMBANK CITY COUNCIL Adoption of Local Laws

Notice is given pursuant to Section 119 (3) of the Local Government Act 1989 that at a meeting of the Council of the City of Brimbank held on 8 October 1996, the Council resolved to make the following Local Laws:

### Local Law No. 3—Animals and Birds

This Local Law is aimed at ensuring that residents who keep animals and birds do so in a hygienic manner and do not cause detriment to neighbours. It requires animal and bird owners to obtain a permit to keep more than the number of species designated under the Law. It also proposes that "on leash" areas for dogs be identified so that all other areas of open space will be available for dogs to be "off leash" at all times provided they are under the effective control of their owner.

### Local Law No. 4-Municipal Amenity

This Local Law imposes limitations on a range of activities and requires authorisation by Council e.g. Storage of Machinery or second hand goods on premises, penalties for Audible Intruder alarms (car and house), use of recreational vehicles, the requirement that temporary sanitary facilities be provided on building sites, placing of recycling bins, unsightly or dilapidated buildings, the siting of caravans, circuses and festivals.

### Local Law No. 5-Keilor Golf Course

This Local Law provides for the use and management of the Golf Course. The Law essentially prohibits activities other than the use of the Golf Course for playing golf. It allows the managers of the Golf Course to enforce this Local Law.

### Local Law No. 6-Municipal Places

This Local Law identifies certain behaviour and conduct that is unlawful so as to enable members of the public to use and enjoy public places under Council control. Behaviour that is harmful or interrupts the quiet enjoyment of municipal places can attract a penalty notice.

### Local Law No. 7-Library

This Local Law provides for the use of Libraries in the municipality and gives power to Library staff to impose penalties for conduct that is contrary to the intended use of the Library and its facilities.

### Local Law No. 8-Roads and Streets

This Local Law establishes a system for the use and management of roads in the municipality. It places a number of restrictions on the use of roads, for street or road side trading, advertising, busking, horse riding, eating. The Local Law requires people who wish to use the roads for activities other than the use of the roads for driving, to obtain a permit from the Council.

The purpose of proposed Local Law No. 2 is to regulate the management of roads and traffic and to control vehicles and animals on roads

The general purport of proposed Local Law No. 2 is to:

- (a) Provide for the peace, order and good government of the municipal district of the Council;
- (b) Provide for the administration of Council powers and functions;

- (c) Provide for the management of roads and traffic by regulating and controlling obstructions to pedestrians and vehicles, controlling road names and property numbers, vehicle crossings and fences for animals;
- (d) Provide for control of vehicles and animals on roads by restrictions on vehicles likely to damage roads, parking of heavy vehicles, advertising signs on roads, roadside trading, displaying goods for sale on roads, placing outdoor eating facilities and bulk rubbish containers on roads, occupying roads for works, repairing of vehicles and depositing of substances on roads, street parties, processions and functions on roads and disposal of water on roads.

The purpose of proposed Local Law No. 3 is to regulate the behaviour of and smoking by people in public places and the consumption of alcoholic beverages.

The general purport of proposed Local Law No. 3 is to:

- (a) Provide for peace, order and good government of the municipal district of the Council;
- (b) Provide for the administration of Council powers and functions;
- (c) Provide for the regulating of behaviour of persons in municipal places;
- (d) Provide for the regulating of smoking in areas declared by Council to be smoke free:
- (e) Provide for the regulating of consumption of alcoholic beverages on streets and roads in certain towns in the municipal district and for restricting the consumption of alcoholic beverages in certain places in the municipal district.

The purpose of proposed Local Law No. 4 is to provide a safe and healthy environment and to regulate activities which may be dangerous or detrimental to the quality of life in a municipal district.

The general purport of proposed Local Law No. 4 is to:

 (a) Provide for the peace, order and good government of the municipal district of the Council;

- (b) Provide for the administration of Council powers and functions;
- (c) Provide for the safety of people and property by regulating and controlling dangerous and unsightly land, the storage of machinery, burning of offensive materials, discharge from chimneys, use of recreation vehicles, advertising on Council buildings;
- (d) Provide for the regulation of camping on public land and roads and for the conduct of circuses and carnivals;
- (e) Provide controls for the keeping and housing of animals on residential and farming properties and for controlling and restrictions over European wasps on properties;
- (f) Provide controls and regulations for domestic waste, interfering with recyclable material for trade waste and waste hoppers, for transportation of waste, use of and depositing waste at tips, scavenging at tips, dumping of refrigerators at tips and drainage tappings.

The owner of any dog must keep the dog under effective control in all reserves and public places.

### 2. Owner's obligations

A dog may be exercised off a chain, cord or leash in a reserve not designated under this Order, or a public place, if the owner:

- carries a chain, cord or leash not exceeding 1.5 metres in length, sufficient to bring the dog under effective control if the dog behaves in a manner which threatens any person or animal;
- collection and proper disposal of the dog's faeces;
- remains in effective voice or hand control of the dog so as to be able to promptly place the dog on a chain, cord or leash not exceeding 1.5 metres in length if that becomes necessary; and
- does not allow the dog to worry or threaten any person or animal.
- 3. If a dog is off a chain, cord or leash, it must be brought under effective control by means of a chain, cord or leash not exceeding 1.5 metres in length if the dog is, or is likely to be, within 20 metres of:

the principal location of an organised sporting event;

- an occupied children's play equipment area;
- the principal location of an organised public meeting;
- an occupied permanent barbecue or picnic area; or
- any person, not being the owner of the dog, unless that person consents to the dog being off the lead in their presence.


