- some of the patients for personal reasons choose to be seen by a female doctor;
- the Evelyn County Medical Service is a sole practitioner practice and employment of a female doctor will give a gender balance at the practice;
- it is part of the scheme of the Act that employment involving the searching of a person's body can be limited to people of the same sex who are to be searched. It is consistent with this scheme that employment that involves the physical examination of a person for medical purposes should be able to be carried out by a person of the same sex as the person to be examined, if the patient so requests.

The Tribunal grants an exemption from the operation of Sections 13, 100 and 195 of the **Equal Opportunity Act 1995**, to the applicant to advertise for and employ a female doctor, this exemption to remain in force until 20 November 1999.
