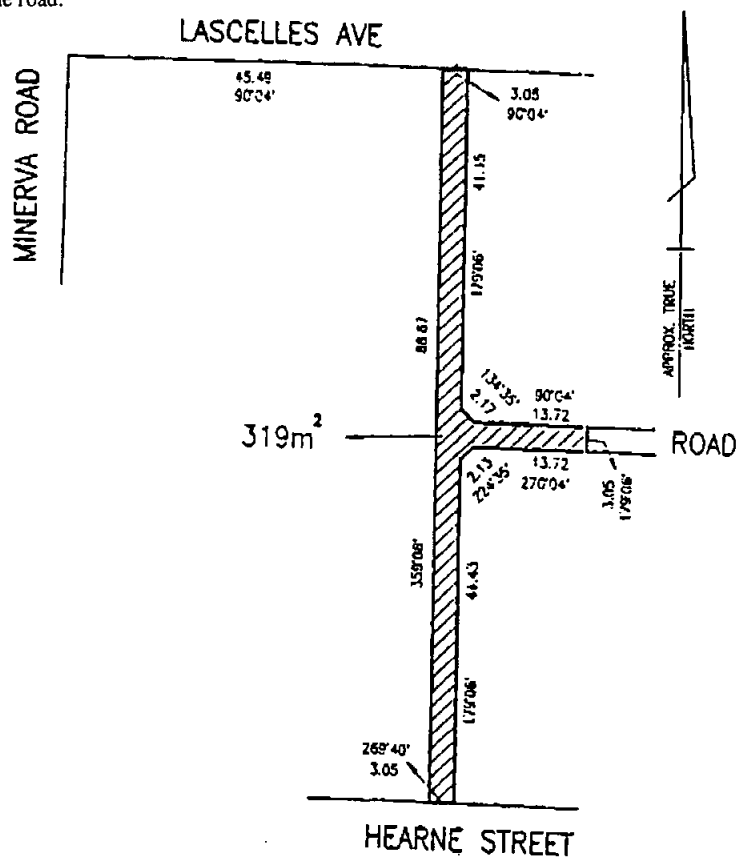

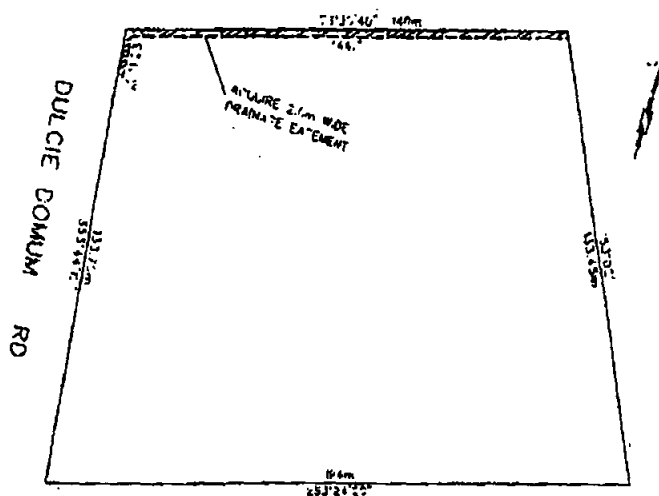

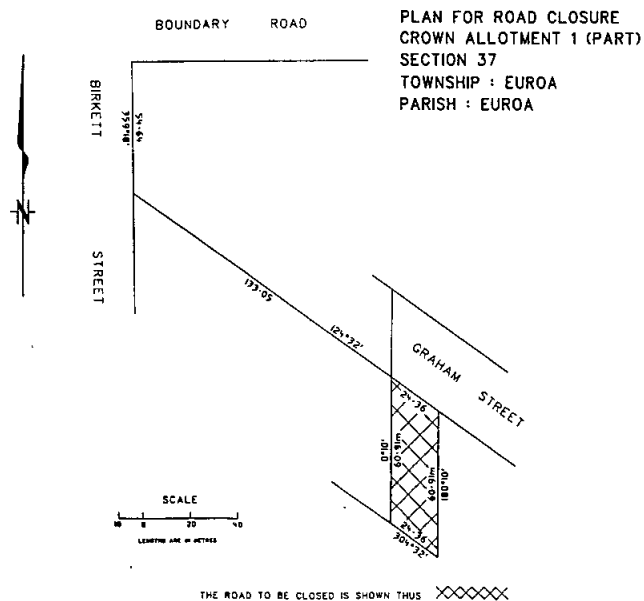

The purpose of proposed local law number 5 is to:

- (a) provide for the peace, order and good government of the municipal district of the Council
- (b) provide for the administration of Council powers and functions
- (c) provide for a safe and healthy environment by prohibiting or regulating activities which may be dangerous or unsafe or detrimental to the quality of life in the municipal district
- (d) provide for the protection of the environment and amenity of the Municipal District and
- (e) prohibit and/or regulate activities with a view to minimising nuisances

The general purport of the proposed local law number 5 is summarised as follows:

Part 1 Preliminary Provisions

Part 2 Protection of Amenity, including:

advertising and bill posting, bulk rubbish containers, building/industrial refuse on roads or Council land, substances from vehicles, animals and livestock, clothing recycling bins, unsightly/dangerous land, motor vehicles and machinery, camping on roads or public places, trees and plant overhanging roads or Council property, chimneys, noise, audible intruder alarms, distribution of materials and literature on Council land, property numbers, collection of recyclable material, and circuses, carnivals and festivals.

Part 3 Recreation Vehicles for Recreational Purposes

Part 4 Moveable Dwellings Including Tents and Caravans

Part 5 Restrictions Applying to Heavy Vehicles in a Residential Area

Part 6 Consumption of Alcohol in Public Places

Part 7 Fire Prevention, including:

lighting fires in the open, incinerators, and barbeques.

Part 8 Administration, including permits, fees, notices to comply, infringement notices, payment of penalties, and powers of authorised officers to impound and act in urgent circumstances

The purpose of proposed local law number 6 is to:

- (a) provide for the peace order and good government of the municipal district of the Council;
- (b) provide for the administration of Council powers and functions;
- (c) provide for the welfare of birds, animals, poultry and rodents that are kept by residents or ratepayers within the municipal district;
- (d) regulate the keeping of any birds, animals, poultry, rodents or bees, the regulating or prohibiting of the keeping of any place, or the storage of any things related to the keeping of birds, animals, poultry, rodents or bees which in the opinion of the Council may be offensive, injurious to health or dangerous;
- (e) regulate the keeping of birds, animals, poultry or rodents, with power to limit the number kept on any property within any area within the municipal district;
- (f) regulate the cleanliness of housing and surrounds for birds, animals, poultry or rodents including the manner in which food for such things is kept;
- (g) suppress nuisances;
- (h) prevent objectionable noises at unreasonable times; and to
- (i) repeal local laws of the former municipalities to the extent that any provisions contained in them are inconsistent with this Local Law.

The general purport of proposed local law number 6 is summarised as follows:

Part 1 Preliminary Provisions

Part 2 Keeping of Cats and Dogs, including: restrictions on number of dogs and cats per property

Part 3 Keeping of Rodents and Reptiles

Part 4 Keeping of Other Animals

Part 5 Keeping of Poultry and Game Birds

Part 6 Keeping of Other Birds

Part 7 Keeping of Bees

Part 8 General Provisions, including public health and nuisance issues, litters of animals and permits relating to the number of animals or birds to be kept

Part 9 Administration, including permits, fees, notices to comply, infringement notices, payment of penalties, and powers of authorised officers to impound and act in urgent circumstances

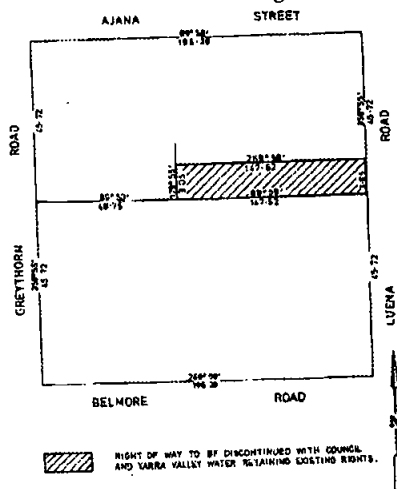

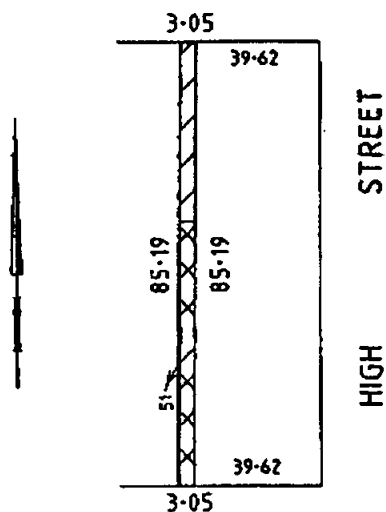

CITY OF WHITTLESEA General Local Law (No. 1 of 1995)

Notice is given that the City of Whittlesea at a meeting held on 5 February 1996, made a local law called the "General Local Law (No. 1 of 1995)".

The purposes of the local law are those of:

- * controlling and protecting public places and Council land;
- * controlling various matters which may adversely affect the amenity of the municipal district and the quality of life of persons within it;
- * providing for a safe and healthy environment for persons within the municipal district;

- * providing for, controlling and managing the use of premises and vehicles;
- * controlling—
 - the consumption and possession of liquor in nominated places;
 - the placing of advertising signs and goods, demonstration of services and sales of goods and services in various locations; and
 - the activities of street vendors and itinerant traders;
- * controlling secondary activities on roads including—
 - trading;
 - placing of goods and equipment;
 - repairs to vehicles;
 - processions, street festivals and street parties;
- * providing for the physical features of the road and adjacent premises to be managed in a way which attends to the safety and convenience of people travelling on or using the road (whether on foot or by vehicle);
- * providing for, controlling and managing traffic and the use of roads and premises by persons, animals and vehicles;
- * controlling—
 - behaviour on roads, public places and Council land;
 - the numbering of premises and naming of roads;
 - the placement of things on roads;
 - obstructions;
 - the use, construction, repair and removal of vehicle crossings and temporary vehicle crossings;
 - the removal and impounding of vehicles and other things; and
 - recycling collection bins;
- * limiting the use of public places by a certain class of vehicle;
- * controlling the parking of vehicles and the payment of parking fees within the municipal district;
- * controlling—
 - fires, incinerators and fire prevention;
 - amenity, condition and use of premises;

- motorised vehicles;
 - advertising, bill posting and junk mail;
 - camping;
 - circuses, carnivals and festivals;
 - animals;
 - drainage;
 - noise; and
 - the collection and disposal of rubbish;
 - * the provision, use and control of receptacles for the deposit and collection of rubbish;
 - * waste management;
 - * maintaining at all times a clean and sanitary condition in the municipal district;
 - * environment control, protection and conservation; and
 - * generally maintaining the peace, order and good government of the municipal district.
- The general purport of the local law is that it:
- * replaces various existing local laws made by the City of Whittlesea;
 - * commences on the date notice of the making of it is published in the Victoria Government Gazette;
 - * applies throughout the municipal district but the extent of operation of its provisions is limited in varying ways e.g. in the case of the existence of a permit or consent, if legislation allows or if the person is involved in a specified group e.g. persons representing the Council, if the premises are in a specified area, etc.;
 - * enables exemptions from the local law;
 - * has definitions and interpretative devices many of which expand or alter the normal meaning of words;
 - * enables things to be prescribed so as to bring them within the scope of various provisions;
 - * enables permits to be issued for matters which would otherwise be contrary to the local law;
 - * enables fees and conditions to apply to permits and other services;
 - * has enforcement provisions which create offences and enables the use of infringement notices and notices to comply and directions;
 - * controls access to and from reserves;
 - * restricts the use of a vehicle in or the taking place of a game, activity or sport in a reserve;
 - * requires dogs to be on a leash in specified circumstances;
 - * ensures precautions against fire hazards;
 - * controls dangerous land and the playing of ball games near roads;
 - * controls the lighting of fires and prohibits the use of incinerators;
 - * prohibits the burning of offensive material and specified substances;
 - * controls circuses, carnivals and festivals, camping and the use of a caravan park or mobile home;
 - * controls signs, bill posting, advertising, pest plants, unsightly land and storage of machinery or second hand goods on premises;
 - * preventing damage or interferences being caused by trees or plants;
 - * controls animals including the number of animals which may be kept, their cleanliness, their keeping and noises made by the animals;
 - * controls birds including the number of poultry to be kept, the siting and construction of bird enclosures, the storage of food for the birds and health aspects associated with the keeping of birds;
 - * regulates the depositing and collection of rubbish and the use of rubbish receptacles;
 - * controls signs and fences which may cause all obstruction;
 - * controls the use of road names and property numbers;
 - * requires vehicle crossings to be provided and used and for the repair of those crossings and parts of a road;
 - * requires effective fencing where premises are used for the grazing of livestock;
 - * controls obstructions on a road;
 - * requires various signs to be obeyed;
 - * restricts the leaving of shopping trolleys, the use of toy vehicles, the riding of horses and the driving of livestock;

- * controls outdoor eating facilities on roads;
- * regulates interfering with or damaging roads;
- * regulates the placing of various items (e.g. rubbish, shopping trolleys, advertising signs, displays of goods and services, chairs and tables, obstructions etc) and the conducting of various activities (e.g. repairing vehicles, camping, consuming liquor, the erection of hoardings, protective barriers etc) on a road, public place, Council land or in a specified position;
- * prohibits the leaving of unregistered, derelict or abandoned vehicles on a road, public place or Council land;
- * prohibits the falling of certain substances onto a road or into a drain and requires a specified procedure to be followed where that occurs;
- * regulates the holding of street parties, street festivals and processions;
- * regulates the itinerant sale of goods and services, displays, demonstrations and sales, soliciting trade and similar activities and collections;
- * regulates limited time parking and the payment of fees for parking;
- * regulates the placing of certain vehicles and structures used in relation to the selling of goods or services;
- * seeks to prevent untrue representations that a person providing goods or services is authorised by the Council or that the Council requires that person to be used;
- * regulates interfering with or damaging Council land or things on it;
- * controls the dumping of refrigerators or similar containers;
- * controls drainage tappings and recycling collection bins;
- * controls the parking and repair of vehicles in residential zones and seeks to reduce noise created by vehicles in noise sensitive areas or during noise sensitive times;
- * controls certain activities in relation to motor vehicles, machinery, goods or materials;

- * regulates the conduct of persons in Council reserves and prohibits certain conduct in those reserves;
- * controls noise;
- * prohibits material of various types being left on a road;
- * controls activities which interfere with specified types of property;
- * has procedural provisions dealing with applications for permits, the granting of permits and the amendment, suspension or cancellation of permits;
- * various forms for use in conjunction with the local law; and
- * has schedules enabling the identification of certain places for the purposes of the local law to be more easily made.

The Local Laws will come into affect on 15 February 1996.

The purpose and general purport of the Local Laws are:

Local Law No. 2—Streets and Roads

- To provide for and control the management of traffic, use of roads by persons, and vehicles and animals and to regulate the parking of vehicles for the safety and fair use by people in the municipal district;
- to provide for the peace, order and well being of people in the municipal district;
- to provide for the physical features of the road and adjacent properties to be managed in a way which attends to the safety and convenience of people travelling on or using the road (whether on foot or by vehicle);
- to control various types of vehicles and animals for the safety and convenience of road users;
- to preserve and protect as far as possible the Council's assets from damage which may be caused from extraordinary use of streets and roads within the municipal district;
- preventing the spread of disease in the municipal district; and
- protect council land and prohibit, regulate and control the discharge of water thereon;
- to control and regulate secondary activities on roads including:
 - (i) trading;
 - (ii) the placing of goods and equipment;
 - (iii) repairs to vehicles; and
 - (iv) parties, festivals and processions

in a fair, equitable and safe manner which does not compromise the primary need for the passage and repassage of people and goods; and

- to provide free and safe access for people with sight and movement impairment or disabilities; and
- to provide for the safe and efficient management and control of parking on roads in the municipal district;
- to provide mechanisms to manage and control parking so as to cause minimal disruption, danger or nuisance to the users of Council's parking facilities.

Local Law No. 3—The Environment

- To provide a safe and healthy environment in which the residents of the municipal district can enjoy a quality of life that meets the general expectations of the community; and
- to prohibit, regulate and control activities which may be dangerous or unsafe or detrimental to the quality of life in an environment of the municipal district; and
- to facilitate the provision of general public services, health and other community services, property services, recreational and cultural services and other services in a way which enhances the environment and quality of life in the municipal district; and
- to control nuisances and noise, odour and smoke emissions, and other discharges to the environment which may adversely affect the enjoyment of life within the municipal district or the health, safety and welfare of persons within the municipal district; and
- in a way which is consistent with, and in furtherance of, the objectives specified above to prohibit, regulate and control activities and circumstances associated with:
 - (i) smoke emission, particularly emission from burning material and from chimneys; and
 - (ii) the use of recreational vehicles which are not used on appropriate land or reserves; and
 - (iii) dangerous and unsightly land; and
 - (iv) advertising and bill posting; and
 - (v) camping and temporary dwellings; and
 - (vi) circuses, carnivals and festivals; and
 - (vii) quarrying; and
 - (viii) water quality, including interference with water courses; and

- (ix) animals, including animal numbers and the keeping and control of animals birds and insects; and
- (x) disposal of waste including behaviour associated with tips; and
- (xi) the prevention of fruit fly; and
- (xii) building site controls, satellite dishes, building works and noise and dilapidated buildings; and builders sanitary conveniences.

Local Law No. 4—Municipal Places:

- To allow and protect the quiet enjoyment by people of municipal places within the municipal district; and

- to enable people in the municipal district to carry out their day to day activities and to enjoy their recreational pursuits without having their peace and enjoyment interfered with or destroyed; and

- to recognise and respond to community expectations relating to the quality of life they expect and require and are capable of influencing; and

- to control and prevent behaviour which is a nuisance, or which affects the enjoyment of recreational or other facilities; and

- to enable the community and visitors and their families who use municipal places that are available to the public, to be confident in their choice of the use of those facilities or places; and

- to protect Council and community assets and facilities on or in municipal places; and

- in a way which is consistent with, and in furtherance of, the objectives specified in paragraphs (as listed above) to prohibit, regulate and control:

- (i) behaviour in municipal places which is boisterous or harmful or intimidating;
- (ii) behaviour in municipal places which is offensive, dangerous or threatening or which, for other reasons, is inappropriate in a municipal place;
- (iii) the places and times at which alcohol may be consumed or possessed;
- (iv) smoking in specified circumstances and places;

- to provide generally for the peace, order and good government of the municipal district; and

- to provide for the administration of the Council's powers and functions.
