MELBOURNE CRICKET GROUND (OPERATION OF FLOODLIGHTS) ORDER No. 4/1997

I, Marie Tehan, Minister for Conservation and Land Management, make the following Order:

Title

1. This Order may be cited as the Melbourne Cricket Ground (Operation of Floodlights) Order No. 4/1997.

Objectives

2. The objectives of this Order are to-

- (a) specify the days and times during which the floodlights affixed to the floodlight towers at the Melbourne Cricket Ground may be operated; and
- (b) specify the purposes for which the floodlights may be operated on those days; and
- (c) make provision in relation to vehicle entry into the Yarra Park Reserve on days on which the floodlights are being used.

Authorising Provision

3. This Order is made under section 3 of the **Melbourne Cricket Ground Act 1984**.

Revocations

4. The Orders described in the Schedule are revoked.

Floodlights may be operated on certain days at certain times and for certain purposes

5. The floodlights affixed to the floodlight towers at the Melbourne Cricket Ground may be operated-

- (a) for the purpose of conducting any activity on the arena at the Melbourne Cricket Ground between 10.00 am and 8.00 pm on any day, including those specified in sub-clause (b); and
- (b) for the purpose of playing Australian Football League matches on the arena at any time after 8.00 pm on the following days-
Sunday 7 September 1997;
Friday 12 September 1997;
Saturday 13 September 1997;
Sunday 14 September 1997;
Friday 19 September 1997;
Saturday 20 September 1997;
Sunday 21 September 1997; and
- (c) for the purposes of aligning, testing, commissioning or repairing of the floodlights, between 8.00 pm and 10.00 pm on any day.

Yarra Park Reserve - Entry of vehicles

6. On any day on which the floodlights affixed to the floodlight towers at the Melbourne Cricket Ground are permitted to be used for the purposes specified in Clause 5(b), vehicular traffic is not permitted to enter into the Yarra Park Reserve by way of Vale Street after 5.00 pm.
